Whereas the National Commission for Scheduled Tribes (NCST), as per the Constitutional mandate and as per powers conferred upon it under Article 338 A of the Constitution of India has decided to investigate into the aforementioned matter. It is informed that the case was earlier discussed in the Commission during the Sitting held on 15.11.2018 and a copy of the proceedings of the sitting was intimated to all concerned for submission of report. However, the requisite action taken report is still awaited.

- 2. Shri Nand Kumar Sai, Hon'ble Chairperson, National Commission for Scheduled Tribes has again fixed a Sitting in the Commission at New Delhi on 11.01.2019 at 02.00 P.M. for investigation/inquiry/ action to be taken in the matter.
- 3. Accordingly, you are requested to appear in person for examination before the Hon'ble Chairperson on the above scheduled date and time along with full facts and all relevant original records/documents pertaining to the case. A detailed report in the case as sought by the Commission should be submitted to the Commission before date of Sitting positively.
- 4. Please take notice that in case you fail to attend the sitting, the Commission is at liberty to exercise the powers of Civil Court under Clause (8) of Article 338A of the Constitution of India for enforcing your attendance before the Commission.
