PROCEEDINGS OF SITTING HELD ON 09.10.2018 CHAIRED BY SMT. MAYA CHINTAMN IVNATE, HON'BLE MEMBER, NATIONAL COMMISSION FOR SCHEDULED TRIBES (NCST) IN THE MATTER REPRESENTATION OF SHRI K. NARAYANA RAO, PRESIDENT, FORUM FOR SOCIAL JUSTICE, GUNTUR REGARDING GRABBED SCHEDULED TRIBES LAND BY NON ST PEOPLE.

Date of Sitting: 09.10.2018

The petitioner Shri K. Narayana Rao, President, Forum for Social Justice, Guntur vide his representation dated 25.07.2018 has submitted grievances of grabbed ST land by non ST people. He alleged that some non ST people has grabbed Scheduled Tribes lands to the extent of Ac. 2.30 cents covered under Survey No. 86A in Sakhamuru Village in which it is claimed the lands were originally allotted for house site @ 0.04 cents to each ST family in the year 1991. The petitioner has requested to remove the encroachment and grant pattas under Land Pooling Scheme to the poor Scheduled Tribe families.

- The NCST vide its letter dated 31.07.2018 issued notice to the District Collector & Magistrate, Distt. Guntur (Andhra Pradesh), the District Superintendent of Police, District - Guntur (Rural) (Andhra Pradesh) and the Commissioner, Capital Region Authority (CRPA), Govt. of Andhra Pradesh for seeking report. No reply has been received from the concerned authorities. Therefore, Smt. Maya Chintamn Ivnate, Hon'ble Member, NCST has fixed a Sitting on 09.10.2018 with the all authority concerned for discussion in the matter. Accordingly sitting notices were issued.
- The RDO and ASP, Thullur appeared before the Commission on 09.10.2018. The petitioner was also present on the day of sitting.
- 4. The case was discussed in detail. At the outset, the Hon'ble Member, NCST asked the petitioner to submit his grievances. Accordingly, the petitioner submitted to the Commission that the land allotted to the Scheduled Tribe families by the Government was grabbed by non ST people to the extent of Ac. 2.30 cents covered under Survey No. 86A in Sakhamuru Village, District Guntur. The said lands were originally allotted for house site @ 0.04 cents to each ST family in the year 1991. They have made several complaints against encroachment/grabbing of land as well as grant of pattas under Land Pooling Scheme to the ST families before the higher authorities. But no action has been taken in the matter so far by the District Administration as well as State Government authorities.

Thereafter, the Hon'ble Member, NCST asked the Officers appeared to explain the case. The RDO and ASP, Thullur informed the Commission that the Competent Authority, LPS Unit-19, Sakhamuru Village, Thullur Mandal, Guntur District has issued

Land Pooling Scheme Notification under Rule 6(2) of the AP Capital City LPS (F&I) Rules, 2015, duly inviting objections to be filled in Form 9.2 and consent applications in Form 9.3 expressing willingness to participate in Land Pooling Scheme (LPS). However, the matter is under consideration. In addition, the concerned District administration is co-operating to the Scheduled Tribes families in that area for the occupied land.

- 5. The Commission observed that some land has already been allotted to the Scheduled Tribe families in that area by the concerned administration in that time, which was earlier grabbed by some non STs. The District Administration has also assured to grant pattas to the ST families. However, the Commission recommends that allotted land to Scheduled Tribes should not be disturbed and continue to be kept in possession of Scheduled Tribe families in land records through proper procedures. It may also be ensured that no harassment/injustice should be meted out to the Scheduled Tribe families and the incidence of grabbing of Scheduled Tribe lands by the non STs should not be happened in future.
- 6. An action taken report in the matter should be submitted before the Commission within 30 days from the receipt of the proceedings of the Sitting.
