Whereas the National Commission for Scheduled Tribes has decided to investigate the aforementioned matter in pursuance of the Constitutional mandate and as per the powers conferred upon it under Article 338A of the Constitution of India. (on the above subject, a sitting was convened on 25 10.2018 at NCST, New Delhi. Action taken/ proposed to be taken on the recommendations of Commission has not been received from the concerned Department. Further, sitting was fixed on 14.12.2018 and 23.01.2019 but due to non-appearance of officers from Govt. of Gujarat sitting were cancelled. Moreover, NCST's vide letter of even No. dated 23.01.2019 has fixed the sitting for 15.02.2019 with the officers of Revenue Department, Govt. of Gujarat, a copy of the letter endorsed to your office. No one on behalf of Revenue Department of Govt. of Gujarat appears in the sitting).

- 2. Shri H.C. Vasava, Hon'ble Member, National Commission for Scheduled Tribes has fixed a Sitting in the Commission at New Delhi on 28/02/2019 at 1230 Hours at 6th Floor, 'B' Wing Lok Nayak Bhawan, Khan Market, New Delhi for investigation/inquiry/action to be taken in the matter.

Accordingly, you are requested to attend the sitting or depute an officer (not below the rank of Joint Secretary to the Govt. of India) who is duly authorized to take decision on your behalf in the matter along with full facts and all relevant original records/documents pertaining to the case on the above scheduled date / time of sitting.
- 4. It is also requested to submit a written statement on behalf of your Department on the present position of the case.
