Whereas the National Commission for Scheduled Tribes has decided to investigate the aforementioned matter in pursuance of the Constitutional mandate and as per the powers conferred upon it under Article 338A of the Constitution of India. (on the above subject, a sitting was convened on 30.08.2018 by the NCST at Gandhinagar. Action taken/ proposed to be taken on the recommendations of Commission has not been received from the concerned Department. The NCST's vide letter of even No. dated 23.01.2019 has fixed the sitting for 15.02.2019 with the officers of Revenue Department, Govt. of Gujarat, a copy of the letter endorsed to your office. No one on behalf of Revenue Department of Govt. of Gujarat appeared in the sitting).
