Proceedings of the Sitting held under the Chairmanship of Shri Ravi Thakur, Hon'ble VC, NCST on the representation, dated 24/12/2015 received from Smt. Arika Sherpa, R/o House No. 7, 1st Safdarjung Lane, behind Indira Gandhi Museum, New Delhi regarding admission of her son in Sanskriti School, New Delhi.

Hon'ble Vice Chairperson, NCST fixed a Sitting with the Secretary, DoPT for discussion in the matter on 28/04/2016 at 3: 00 PM. Accordingly, notice of Sitting was issued.

Discussion

Shri M.S. Subramanya, Director & Chief Welfare Officer, Shri N. Sriraman, Director and Shri Chirabrata Sarkar, Under Secretary, DoPT, appeared before the Commission.

Initiating the discussion the Director, DoPT informed that Master Chozay Sherpa had taken admission in Sanskriti School against General category. Mr. Sherpa was informed that vacancy was in General Category and he had duly filled the enrolment form. He further informed that presently the EWS/disadvantage category seats are full and there is no vacancy to adjust this child against the quota. He further stated that for availing the benefits of EWS category residence of student should be within the one K.M. range of School. In the present case student is not residing in one K.M. range, hence he is not eligible for EWS category benefits.

The petitioner stated that she was not informed about all this. She was trying to meet the Principal of School for more than two years but she was not given appointment to meet her.

The Hon'ble chair observed that Rules/Regulations relating to admission in School should be transparent and clear. There should be no confusion. DoPT should arrange a meeting between petitioner and the Principal, Sanskriti School for redressal of her grievance / sort out problems before 10th May 2016. In case grievance persist Officers of Department of Education, Delhi Govt. who are nodal Officers for EWS category may also be called in next meeting to resolve the issue.

Meeting ended with a vote of thanks to the chair.
