- The NCST has taken up the matter and discussed the grievances of the petitioner with the officers of CBDT and Department of Revenue under Ministry of Finance.
- During the course of the discussion the Petitioner informed the NCST that he was denied appointment to the post of Member of CBDT being senior most in the cadre and being a member of ST community.
- 3. The officers of the CBDT and Department of Revenue informed the NCST that the issue of appointment of the Member in the Board of CBDT is decided by the Govt. of India level through Cabinet Committee. The Ministry of Finance and CBDT do not have any role in this regard.
- 4. The Commission discussed and examined the matter and it was observed that it is the prerogative of the Govt. of India to take a decision to appoint the member in the Board of CBDT and the NCST does not have any role to decide such cases of its own. However, the NCST recommends that while considering the appointment of members of the Board, the Petitioner's name should also be considered being his seniority and his belongingness to ST community.
