Minutes of the sitting held under the Chairmanship of Shri Hari Krishna Damor, Hon'ble Member, in the representation of President, Wentern Sumi Kukami Hoho, Dmapur, Nagaland regarding construction of upgradation of inter-state road from Bokajan-Wokha to R. Hovishe via Aghunaqa Hq. Dimapur.

- The representation dated 13.12.2018 of President, Wentern Sumi Kukami Hoho, Dimapur received in the Commission regarding construction of upgradation of inter-state road from Bokajan-Wokha. The NCST took up the matter with the Chief Secretary, Govt. of Nagaland, for facts and comments on 09.01.2019. The response was not received. Accordingly, the Commission fixed the sitting on 8.03.2019 to discuss the matter with the State Govt. Official, Chief Engineer, Ministry of Road Transport and Highways and the petitioner to resolved the issue.
- 3. Initiating the discussion, Shri Hari Krishna Damor, Hon'ble Member, NCST asked the petitioner to submit his grievances. Shri Vihuto Yeptho, explained that the Commission may please be intervene in the matter with the Ministry of Road Transport and Highways to accord the sanction in the matter at the earliest.
- The Chief Engineer, Ministry of Road Transport and Highways has informed that the Chief Minister, Nagaland vide D.O. letter dated 14th July, 2018 has requested the Union Minister of Road Transport & Highways to replace all the six projects submitted earlier have been reviewed and it has been decided to replace all the projects and recommend the following mentioned below for sanction under the Economic Importance and Inter State Connectivity Schemes.
- 6. After detailed discussions with the officers of Ministry of Road Transport and Highways, State Government and the Petitioner. Shri Hari Krishna Damor, Hon'ble Member, NCST advised /suggested that the said projects may be reconsidered by the State Government and submitted to the Ministry of Road Transport and Highways for approval on priority basis and completed this work within three months from the date of the sitting of the Commission. Action taken/to be taken in the matter may be intimated to the Commission.
