Minutes of sitting held in the NCST's Headquarters on 15/02/2019 at 11:00 A.M. under the chairmanship of Shri H. C. Vasava, Hon'ble Member, NCST in the case of Shri Babu Lal Meena, Track Maintainer-III (Village & Post - Gandrawa (Dadar ki Dhani) Via - Bhandarej, Tehsil - Sikray, District - Dausa, Rajasthan) regarding not releasing him to join the Railway electrification Jaipur on deputation by the authorities of South Central Railway, Nanded Division.

Shri Babu Lal Meena, vide representation dated 27.08.2018 has alleged that the South Central Railway is not releasing him to join the Railway electrification Jaipur on deputation basis. The matter was referred to the Chairman, Railway Board and Divisional Railway Manager, South Central Railway, Nanded vide letter dated 25.09.2018 and subsequent dated 30.\$11.2018. The response was not received from the South Central Railway. Hence, Hon'ble Member decided to discuss the matter with the Railway Authorities on 15.02.2019. Accordingly, notice for sitting has been communicated to all concerned and petitioner vide letter dated 23.01.2019.

In response to sitting notice, the General Manager (GM), South Central Railway, Secunderabad vide D.O. No. SCR/P-HQ/875/EE/P.Way dated 11.02.2019 had informed that the grievance of the applicant has been resolved. A copy of the letter No. SCR/P.NED/Misc/W3/Engg dated 08.02.2019 of DRM, Nanded division (P) addressed to CPM/RE/Jaipur regarding forwarding of application of Shri B.L. Meena also enclosed with the letter. GM had deputed Chief Personnel Officer/ Admin, South Central Railway to attend the sitting and also requested the presence of Chairman, Railway Board and GM, in the above case may kindly be dispensed.

The Railway Board had not furnished any communication, but representatives from Railway Board appeared in the sitting. The petitioner appeared before the Commission and informed that the Senior Personnel Officer, Railway Electrification, Jaipur vide letter No. RE/JP/Pers/205/183/Pt.I dated 1302.2019 had requested the Divisional Railway Manager (P), South Central Railway, Nanded to spare Shri Babu Lal Meena, TMTR-IV to join this office on transfer basis. A copy of this letter was given to the Commission in the sitting.

The representatives of Railway Board informed that they have no information to furnish in the matter, since the Chief Personnel Officer, Admin South Central Railway is likely to join the sitting, but due to Hon'ble Prime Minister programme at New Delhi Railway Station he is unable to join. Chief Personnel Officer will visit the Commission with the facts and action taken by the South Central Railway.

The Hon'ble Member asked the petitioner to explain the grievance. The petitioner informed that since the South Central Railway has forwarded his application to CPM/RE/ Jaipur to accommodate him to RE/Jaipur (vide their letter dated 08.02.2019) and Senior Personnel Officer, Railway Electrification Jaipur had requested to spare to join their office (vide their letter dated 13.02.2019), he may be allowed to join the duty at RE/Jaipur.

The petitioner has also informed that the Department has not sanctioned/ allowed the leave to attend the sitting on 15.02.2019 at Lok Nayak Bhawan, New Delhi and requested the Railway authorities may be instructed the leave from 13.02.2019 to 17.02.2019 in his favour to attend the sitting at NCST be allowed/ sanctioned.

After the sitting, the Chief Personnel Officer (Admin) South Central Railway, SCR visited the Commission and provided a copy of the "Office Order No. 55/2019" bearing No. SCR/P.NED/Misc/W3/Engg dated 14.02.2019 of South Central Railway, Nanded Division regarding posting of staff to work in RE/Jaipur on deputation basis- case of Shri B.L. Meena, Track Maintainer-III/SSE/P.Way/KNW in Civil Engineering Department in Nanded Division. In this order, certain conditions have been described. The petitioner submitted a representation dated 15.02.2019 addressed to Divisional Railway Manager, South Central Railway, Nanded to relieve from the duty and to join at RE/Jaipur (copy at Annexure-I).

After discussions with the officers of Railway Board, petitioner in the sitting and letter dated 14.02.2019 received from the Chief Personnel Officer, (Admin) SCR, the Hon'ble Member recommended/ suggested that the South Central Railway may accept the representation dated 15.02.2019 of Shri Babu Lal Meena and relieve him to join the duty at RE/Jaipur, immediately. The leave from 13.02.2019 to 17.02.2019 for attended the sitting on 15.02.2019 at NCST may also be sanctioned/ allowed to Shri B.L. Meena as per Rules. The South Central Railway, Nanded Division should submit the action taken/ to be taken in the matter to the NCST within a month from receipt of the proceedings of the sitting.
