### (1) Case No. SDP/4/2018/STGDN/DELAAL/RU-I

Background of the case: Mrs. Sadhna Dilip Patel, Amli, Brahman Falia, Silvassa, UT of Dadra & Nagar Haveli had represented to the NCST regarding payment of Compensation in the matter of Land bearing survey No. 425/1/3/1 admeasuring Hect. 0.36 situated near Ring Road at Village Amli, Silvassa. The NCST vide letter dated 23/05/2018 referred the representation to the Administrator, U.T. of Dadra & Nagar Haveli, Silvassa for furnishing facts and comments in the sitting scheduled for 24/05/2018 to discuss the various matters of Scheduled Tribes of Dadra & Nagar Haveli.

In the sitting held on 22.01.2019, the petitioner was present and no one was appeared from the Administration of Dadra & Nagar Haveli. The petitioner informed that the opposite party (Shri Yogeshbhai Mohanbhai Patel) has filed an Appeal before the Administrator, Dadra & Nagar Haveli against the order dated 23.11.2018 passed by RDC. In addition to this, a case has also been filled before the Hon'ble Court of the Civil Judge, Dadra & Nagar Haveli, Silvassa by Shri Yogeshbhai Mohanbhai Patel. It was also informed that no relief has been given by the District Administration/ Municipal Corporation in respect of removal of gutter line in the land of the petitioner. The petitioner requested for justice.

After discussions in the sitting held on 22.01.2019, the Hon'ble Member suggested/ recommended that the UT Administration of D & NH should submit the action taken/ to be taken report for handing over the amount of the land to the petitioner and for removal of gutter line laid by the Municipal Corporation in the land of the petitioner to the NCST, within a month from receipt of the proceedings of the sitting.

The minutes of sitting was sent on 20.02.2019 to the concerned agencies for sending the action taken report on the suggestions/ recommendations of the Commission.

In the meeting dated 06.03.2019 at Silvassa, the Collector, Silvassa informed that the matter is pending before the Administrator, UT of Dadra & Nagar Haveli (D & NH) and also in the Court of Civil Judge, D & NH at Silvassa. The District Administration is not in position to intervene in the matter. In regard to removal of gutter line, the Administration will initiate necessary action for resolving the issue. The District Collector, also assured that action will be initiated against the Mamlatdar who entered the name of Shri Yogeshbhai Mohanbhai Patel in the Revenue record in respect of land pertaining to the petitioner.

# (2) <u>Case No. MDP/9/2018/STGDN/DELAAL/RU-I</u>

Background of the case: Shri Maganbhai Dahyabhai Patel vide representation (s) August 2018 and 23.10.2018 had requested for justice on. (i) action against the opponent who has put the duplicate signature in sale deed and (ii) Inquiry against Ex- Mamlatdar, D & NH Silvassa for misusing his power in regard to land matter, respectively. The representation (s) were referred to Administrator, UT of D & NH and District Collector, D & NH for facts and comments on 31.10.2018. The facts and comments from the authorities concerned was not received. Hence, Hon'ble Member had convened the sitting on 28.11.2018 to discuss the

In the sitting, except petitioner no one appeared from the Administration from Dadra & Nagar Haveli. Further, Hon'ble Member decided to discuss the matter with the concerned authorities and the petitioner in a sitting scheduled for 14.12.2018, which was later scheduled for 17.01.2019, but the sitting dated 17.01.2019 was postponed. The date of sitting was fixed for 23.01.2019 which was also preponed for 22.01.2019.

In the sitting held on 22.01.2019, the petitioner was present and no one appeared from the Administration of Dadra & Nagar Haveli and District Collector, D& NH. The petitioner informed that being a poor man unable to bear the expenses of the Advocate to defend the matter and requested to suggest/ direct District Revenue Authorities for resolving the issue at the earliest. Since no officials attended the sitting, the Commission took a serious view for non-appearance of the official. After discussions, the Hon'ble Member suggested/ recommended that District Collector, Dadra & Nagar Haveli should submit the action taken/ to be taken report in the matter on the representation dated August 2018 of the petitioner. The chronological events of incident should also be made available to the Commission within a month from receipt of the proceedings of the sitting.

The minutes of sitting was sent on 20.02.2019 to all concerned for submitting action taken report on the recommendations of the NCST.

In the meeting held on 06.03.2019 at Silvassa, the District Collector informed that the District Administration is incompetent to take any action against the opponent, who put the duplicate signature in Sale Deed of land bearing No. 207 of Village- Silvassa. It would be better to approach the competent appellate Court to challenge the Sale Deed. The Collector, Silvassa also informed that District Administration will take action against the encroacher on land bearing survey No. 100 Village Sayli. The Administration will take action for regularising the land in name of the petitioner, which is in possession with the petitioner.

## (3) <u>Case No. RRL/5/2018/STGDN/DELAAL/RU-I</u>

Background of the case: Shri Rameshbhai Raviya Lotda, R/o Sayli, Dattupada, Silvassa (Dadra & Nagar Haveli) visited the NCST on 23/05/2018 and stated that Revenue Authority are not issuing certification / pucca entry in the land at Village - Amli, Silavassa. The NCST vide letter dated 23/05/2018 take up the issue with Administrator, U.T. of Dadra & Nagar Haveli, Silvassa for furnishing facts and comments in the sitting scheduled for 24/05/2018 to discuss the various matters of Scheduled Tribes of Dadra & Nagar Haveli.

The date of sitting was fixed for 23.01.2019 which was also preponed for 22.01.2019.

In the sitting held on 22.01.2019, the petitioner was present and no one was appeared from the Administration of Dadra & Nagar Haveli. The petitioner informed that being a poor man unable to bear the expenses of the Advocate to defend the matter and requested to suggest/direct District Revenue Authorities for resolving the issue at the earliest. After discussions, the Hon'ble Member suggested/ recommended that Resident Deputy Collector (S) Dadra & Nagar Haveli should submit the action taken/ to be taken report in the matter within a month from receipt of the proceedings of the sitting.

The proceedings of sitting were sent to all concerned on 20.02.2019 for submitting the action taken report on the recommendations of the Commission.

In the meeting held on 06.03.2019 at Silvassa, the District Collector Silvassa informed that hearings are necessary for enquiring in the said matter, as, it is a Revenue case, challenging the mutation entries/ orders of the year 1976 and it time consuming. However, the Administration will convene the hearings at the earliest, to resolve the issue.

### (4) <u>Case No. LGL/6/2018/STGDN/DELAAL/RU-I</u>

Background of the case: Shri Luxibhai Govind Lotda, R/o Village – Amli, Dokmardi, Silvassa (Dadra & Nagar Haveli) regarding grabbing of land of Scheduled Tribes. The NCST vide letter dated 23/05/2018 referred the issue to the Administrator, U.T. of Dadra & Nagar Haveli, Silvassa for furnishing facts and comments in the sitting scheduled for 24/05/2018 to discuss the various matters of Scheduled Tribes of Dadra & Nagar Haveli.

The NCST convened the sitting on 24.05.2018, 28.08.2018 and 26.10.2018. The sitting was convened on 28.11.2018, in the sitting the petitioner was present and no one was appeared from the Administration of Dadra & Nagar Haveli. Further, Hon'ble Member decided to discuss the matter with the concerned authorities and the petitioner in a sitting scheduled for 14.12.2018, which was later scheduled for 17.01.2019, but the sitting dated 17.01.2019 was

In the meeting held on 06.03.2019 at Silvassa, the District Collector, Silvassa informed that the case will be examined by his office. The new date for hearing of the case will be fixed to resolve the issue.

### (5) Case No. MVP/2/2018/STGDN/DELAAL/RU-I

Background of the case: Representation dated nil received from Shri Maheshbhai Veragbhai Patel and Shri Sanjaybhai Radkabhai Halpati, R/o Amli - Gandhigram, Sivassa, Dadra & Nagar Haveli regarding not measuring the land of the Scheduled Tribes by Survey settlement office of Union Territory of Dadra & Nagar Haveli Administration. Representation(s) were referred to the Administrator, U.T. of Dadra & Nagar Haveli, Silvassa for furnishing facts and comments within 30 days from receipt of the letter dated 11/04/2018.

The NCST convened the sitting on 24.05.2018 and 28.08.2018 with the officers of District Administration, Silvassa and the petitioner. After discussion in the sitting held on 28.08.2018 at NCST, Lok Nayak Bhawan, Hon'ble Member agreed with the suggestions of Mamlatdar, Silvasa and granted three months' time to the District Administration of Dadra & Nagar Haveli, Silvasa for re-examination of the case.

The minutes of sitting was sent to all concerned agencies on 18.09.2018 for furnishing the action taken report on the recommendations/ suggestions to the NCST.
