Minutes of sitting held in the NCST's Headquarters on 11/06/2019 at 12:30 P.M. onwards under the Chairmanship of Dr. Nand Kumar Sai, Hon'ble Chairperson, NCST in the case of Shri Milind V Awad, Gen Secy, All India SCs & STs Railway Employees Association, Central Railway Zone (Zonal Executive Committee) Parcel Bldg, 2nd Floor, CSMT, Central Railway Mumbai, regarding corruption in all India SC/ST Railway Employees Association.

List of participants is annexed.

Shri Milind V Awad, General Secretary, All India SCs & STs Railway Employees Association, (Central Railway Zone), Zonal Executive Committee, Mumbai vide representation dated 27.03.2019 has alleged that the corruption in Central Executive Committee, All India SCs and STs Railway Employees Association. The matter was referred to Chairman, Railway Board and Registrar of Societies, New Delhi on 22.04.2019 for facts and comments.

The Railway Board vide letter dated 14.05.2019 had furnished the facts and informed that there were court cases between the Associations (The petitioner Association and All India SCs & STs Railway Employees Association). It was also informed that elections were held in a due and democratic way as had been certified by the election observer and the President and the General Secretary of CEC/AISC/STREA vide their jointly signed letter dated 29.10.2018 had submitted a list of 06 newly elected office bearers of the said Association based on the election held on 28.10.2018 requesting for its circulation for a period of three years from the date of election i.e. 28.10.2018 to 27.10.2021. Having examined the authenticity of the same, the list was circulated vide Railway Board's letter No. 2018-E(SCT)I/22/12 dated 30.10.2018 to all the Zonal Rlys/PSUs etc.

The Hon'ble Chairperson fixed the sitting on 11.06.2019 to discuss the matter with the Chairman, Railway Board, Registrar of Societies and General Secretary, All India SCs & STs Railway Employees Association, (Central Railway Zone), Zonal Executive Committee, Mumbai. The DG (Personnel) and EDE (Res) of Railway Board on behalf of Chairman, Railway Board, Naib Tehsildar, on behalf of Registrar of Societies and General Secretary and other designated officers in the All India SCs & STs Railway Employees Association, (Central Railway Zone), Zonal Executive Committee, Mumbai were appeared in the sitting.

The Hon'ble Chairperson asked the General Secretary, All India SCs & STs Railway Employees Association, (Central Railway Zone), Zonal Executive Committee, Mumbai to explain the grievances and problems. It was informed that the Railway Board vide letter dated 30.10.2018 has circulated the list of elected office bearers of Central Executive Committee, All India SCs & STs Railway Employees Association, which is fake and the members of Association are not entitled for benefits provided by Railway Management. The petitioner Association is genuine and needs to be recognised by the Railway authorities.

The Hon'ble Chairperson asked the representatives of Railway Board to explain the facts. The representatives of Railway Board reiterated the facts furnished by the Railway Board to the Commission, vide letter dated 14.05.2019. It was also informed that before taking any decision in the matter, the President or General Secretary of Central Executive Committee, All India SCs & STs Railway Employees Association should also be heard for facts.

The Hon'ble Chairperson asked the representative of Registrar of Societies to explain the facts and action taken by them. The representative informed that the suspension and expel power rests with the General Body of the Association.

After detailed discussions with the representatives of Railway Board, Registrar of Societies and the General Secretary, All India SCs & STs Railway Employees Association, (Central Railway Zone), Zonal Executive Committee, Mumbai, Commission decided that a sitting will be convened with the opponent i.e. President or General Secretary of Central Executive Committee, All India SCs & STs Railway Employees Association for discussion to find out the facts. It was recommended that concerned Railway authority should allow leave, as per Rules to the Employee of Railway's who attended the sitting on 11.06.2019 at Lok Nayak Bhawan, New Delhi.
