To review and follow up the decisions taken in the meeting by NCST on 22.01.2019 with Secretary, Ministry of Civil Aviation and CMD, Air India on the complaint of above employees, a meeting was held by the Commission.

As per decisions taken in the last meeting a three-member Committee was constituted under Mr. Vinod Hejmadi, Director-Finance, Air India and committee was asked to submit its report within 15 days. Since report of the Committee and ATR was not submitted to the Commission, a meeting was called on 11.06.2019 which could not be held. However, a meeting was fixed for 18.06.2019 and Secretary, Ministry of Civil Aviation and CMD, Air India were directed to submit the report of the Committee within 03 days.

On 18.06.2019 report of the Committee was discussed in the meeting and it was observed that Committee with a majority view has recommended in favour of petitioners to maintain their seniority in comparison to juniors. It was also observed that the report of the Committee has not been implemented yet by Ministry of Civil Aviation and Air India. During the discussion it was also observed that the cases pending in Supreme Court and High Court are not related
