Sub: Minutes of the Sitting in the case of Shri Abhinav D. Patel, held under the Chairmanship of Hon'ble Vice Chairperson in the National Commission for Scheduled Tribes.

- 1. A Sitting was held under the Chairmanship of Hon'ble Vice Chairperson, National Commission for Scheduled Tribes, to discuss the case of Shri Abhinav D. Patel for his appointment as Assistant Motor Vehicle Inspector in the Dadra & Nagar Haveli in the Conference Room of the National Commission for Scheduled Tribes at 12:00 Noon on 20/06/2016.
- 2. The list of participants is given at Annexure A.
- 3. Initiating the discussion, the Hon'ble Vice Chairperson asked Shri G.S. Rajawat, Collector, Dadra & Nagar Haveli UT, Administration about the reasons for not issuing the appointment orders of Shri Abhinav D. Patel. Shri Rajawat stated that they had already written to Ministry of Home Affairs to clarify whether an outsider ST candidate is eligible for the reservation benefits in Dadra & Nagar Haveli UT.
- 4. Officers from the Ministry of Home Affairs have stated that they propose to hold a Meeting in this regard with the Ministry of Tribal Affairs, Ministry of Social Justice & Empowerment, Ministry of Law & Justice, Department of Personnel & Training and Department of Public Enterprises Selection Board and will come up with a decision in the matter soon but not later than a period of 1 month.
- 5. JS, DoPT (Mrs. Archna Verma) held the position that since Shri Abhinav D. Patel is a migrant ST of the State of Gujarat; Dadra & Nagar Haveli UT, Administration has to keep this fact in mind while finalizing the appointment on this post especially in view of the Presidential order which stress upon the nativity aspect of ST candidate.
- 6. After hearing both the parties, the Hon'ble Vice Chairperson, NCST, inter-alia, advised Ministry of Home Affairs to take a decision in this case and inform the Commission within 4 weeks from the date of communication of these proceedings.
- 7. The Sitting ended with vote of thanks to the Chair.
