NATIONAL COMMISSION FOR SCHEDULED TRIBES

The minutes of the sitting held by Hon'ble Member Smt. Maya Chintamn Ivnate on 25.09.2019 on the representation of Shri D. Chinya from Ranga Reddy District regarding encroachment of his land.

List of participants is attached.

- 2. During the sitting the petitioner informed that he is the absolute owner of the property to an extent of 0.16 guntas covered by survey no. 11/20 and 11/21 out of total extent of 34.07 guntas which is agriculture land situated at Khanammet village, Rajendranagar Taluk, Ranga reddy District, Telangana, through Agreement of Sale with Possession on 4th day of November, 1982 at Hyderabad whereas the Vender is GPA Holder hrough registered document No. 985/1981 registered with Joint Sub registrar-1, Hyderabad. He stated that he was enjoying the above said property for las 35 years, but he was surprised when Mr. Jagdeshwar Reddy influential and rich man came and encroached his land. He made a several visit to complain about this is the office of Local police station and Revenue department, where he misplaced the document for proof so he could not file a complaint. He requested that his land should be returned to him.
- 3. During the sitting, the District officials informed that DC& Tahsildar, Serilingampally had submitted report stating that, as per the Pahani for the year 1966-67, extent Ac. 359-09 gts., is classified as patta and recorded in the name of Gurukul Ghatkesar as pattedar and Ramachandru & others are recorded as possessor. Further as seen from the pahani for the year 1984-85 the land in Sy. No. 11/20 & Sy. No. 11/21 are classified as patta

श्रीनती माया चिंतामण ईवनाले Smt. Maya Chintamn Ivnate सवस्य Mainbar and recorded in the name of Gurukul Ghatkesar as pattedar. As seen from the pahani for the year 2014-15, the land in Sy. No. 11/20 extent Ac. 12-00 gts., & Sy. No. 11/21 extent Ac. 0-04 gts., are classified as Patta and recorded in the name of Gurukul Ghatkesar as Pattedar and Sy. No. 11/20/A extent Ac. 3-23 gts., and Sy. No. 11/21/A extent Ac. 18-24 gts., are classified as Patta and recorded in the name of Survey of India Staff Cooperative Housing Society Limited as pattedar. Further as seen from the 10(6) of ULC Act., the land in Sy. No. 11 along with Sy. Nos., are declared as surplus land with declarant M/s Gurukul Ghatkesar in CC No. H1/4933/76.

- 4. It was also informed that an extent of Ac.633-00 gts., is recorded in the name of Gurukul Ghatkesar trust. Out of which an extent of Ac. 167-30 gts., of land in Sy. No. 5 of Izzathnaar was purchased by AP Housing Board and in turn transferred in favour of National Academy of Construction vide GOMs No. 103, Tranport, Road & Building (R-III) Dept., dated 16.06.1998. Further the remaining area of about Ac. 466-00 gts., of Khanamet village was recorded in the name of Gurukul Ghatkesar Trust. Out of which an extent of Ac. 26-31 gts., was purchased by Survey of India, an extent of Ac. 140-20 gts., was purchased by Co-operative Housing Society, Swamy Ayyappa Society, an extent of Ac.50-00 gts., was purchased by Vishweshwaraiah Society and about an extent of Ac. 6-30 gts., was purchased by Akkineni Nagarjuna.
- 5. As seen from the documents submitted by the petitioner i.e., D Chinya it is found that Sri B Kishan Lal S/o Jagadish Prasad has executed power of Attorney in favour of P Gopala Krishan Rao S/o Ramana Rao vide document No. 985/1981, dated: 02.12.1981 for an extent

Nos. 11/19 to 11/36 and Abadi of Gurukul of Khanamet village, rajendranagar Taluk, Ranga Reddy District. In turn Sri P. Gopala Krishna S/o Ramana Rao has executed an unregistered Agreement of sale with Possession in favour of Sri D Chinya S/o Lachiram to an extent of Ac. 0-16 gts., in Sy No. 11/20 & 11/21 of Khanamet village.

- 6. Further, it was informed that, on field verification, Sri Jakka Ganga Reddy & Naleemela Jagadeeshwar Reddy are in possession and also submitted the copy of documents purchased from Gurukul Ghatkesar Trust, Represented by its President Sri B Krishanlal S/o Jagnnadha Rao (through GPA on 26.04.1992 & 05.041992 and the same was validated in File No. 2417/AR/2015 (609 Sq.yds.,) & 2418/AR/2015 (493 sq.yds.,), dated: 15.05.2015 in Sy. No. 11/20 & 11/21 of Khanamet village, Serilingampally Mandal.
- 7. The Commissioner, Endowments Department, Government of Telangana has addressed a letter to SDM office vide Lr. No. C2/30105/2009, dated 01/11/2017 with a request not to issue any clearances / NOC till completion of the regularization process as per the Judgment of the Hon'ble High Court dated: 12.09.2012 in WP No. 20407/2008, 9714 & 16658 of 2009 subject to the disposal of the SLPs pending before the Hon'ble Supreme Court of India.
- 8. It was also informed that with regard to the ground status the land shown by the petitioner, it is covered by Compound walls and in the possession of 3rd parties i.e., Sri Jakka Ganga Reddy, Naleemela Jagadeeshwar Reddy & others.
