## NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of the Hearing held by Hon'ble Member, Shrimati Maya Chintaman Invate.

Grievance of Smt Angadi Prabhakar, Guntur District regarding action taken against the culprits involved in the murder of Ms Angadi Jyothi and the erring police officials and the implementation of rehabilitation package as per GOMS No. 95.

- 2. After welcoming the participants and their introduction, the petitioner was asked to explain his grievance.
- 3. The petitioner appeared along with ... who stated that the petitioner's sister was brutally murdered on 11<sup>th</sup> Feb., 2019. The FIR was lodged and accused were arrested. Later, the accused were released on bail. Almost 10 moths have elapsed, the charge sheet has not been filed. The post mortem was also not carried out as per procedure. It was done after exhuming the. It was further stated that investigation was negligently carried out. It was demanded that action be taken against the Medical Officer who carried out the post mortem and certain police officials who conducted investigation negligently. It was also pleaded that the case be referred to the CBI for speedier investigation.
- 4. The petitioner further alleged that benefits, as per GOMS No. 95 have not been extended to the aggrieved family so far. The family has however received Rs 4,25,000/- out of total grant of Rs 8,50,000/- and other benefits are yet to be received.
- 5. The District Collector and Superintendent of Police of Guntur District did not appear before the Commission due their pre occupation and the late receipt of Communication from the Commission. The Hon'ble Member however took note the status report as received from the District Collector.

The District Collector also sent letter to Principal Secretary, Tribal Welfare Deptt, A.P on dated 22/11/2019 for seeking permission under the provision fo ;G.O.Ms.No. 95 to provide employment. Further petitioner also submit to that his sister who was brutally murdered was the earning member of ther family and was working part time lab-incharge in Dan-Basco Priyadarshini Pharmacy College, Pulladigunta, District- Guntur.

6. After hearing the Petitioner and his representative, Hon'ble Member advise to Principal Secretary, Tribal Welfare Deptt. Govt.of A.P here to look into the matter in sympathetically way for consideration for employment and also decided to fix next sitting shortly to hear this matter further.
