PROCEEDINGS OF THE SITTING HELD ON 11.12.2019 CHAIRED BY HON'BLE CHAIRPERSON, DR NAND KUMAR SAI REGARDING REPRESENTATION OF SMT BINDU ROY, ADDITIONAL GENERAL MANAGER (NFSG), BSNL WITH REGARD TO DENIAL OF PROMOTION TO HER FOR THE POST OF GENERAL MANAGER

After welcoming the participants and their introduction, the petitioner was asked to explain her grievance.

- 2. The petitioner stated that she was denied the promotion for the post of General Manager although she is eligible as per rules. She stated that she is entitled to be considered for the promotion of GM w.e.f. 1st Jan., 2018 as she had completed combined service of more than 5 years in the grade of Jt. GM and Addl. GM. She also stated that the officers belonging to Civil/Electrical/Telecom cadres have been promoted and brought to the administrative posts in BSNL, and whereas in CSS cadre, where she is the only eligible candidate for promotion, her candidature has been ignored deliberately because she belongs to ST community. In addition, more than 50 officers of Civil/Electrical cadre have been promoted, though, there were no posts available in their cadre. She is the only eligible and deserving officer who is left out for promotion while others were promoted to the post of GMs. Every Jt. GM/Addl GM having 5 years of service has been promoted to the next grade but her rightful claim for the post of GM has been denied. In this regard, she has represented her case before the Competent Authority i.e. CMD, BSNL vide her representations. But so far nothing has been done in the matter.
- 3. Director, (HR), BSNL appeared before the Commission. He, inter alia, stated that she could not be promoted as there was no vacancy available in that cadre. He apprised the Commission that she would be promoted to the post of GM after the vacancy arises in January, 2020 after superannuation of the incumbent officer on 31.12.2019. The Commission also considered the comments of BSNL as received vide its letter dated 23.07.2019
- 4. The Commission is not convinced by the explanation given by the officer of BSNL and felt that the petitioner is senior most and eligible ST candidate to be considered to the post of General Manager. She was entitled to get promotion w.e.f. 01.01.2018 as she had completed eligible service. The Commission, therefore, recommends that the petitioner should be considered for promotion to the post of General Manager w.e.f. 01.01.2018 which is rightful claim. The BSNL authorities will take action to promote the petitioner and will send the action taken report by 15th January, 2020.
