NATIONAL COMMISSION FOR SCHEDULED TRIBES

Proceedings of the sitting held on 06/12/2019 Chaired by Smt Maya Chintaman Invate, Hon'ble Member, NCST regarding Representation of Shri M. Narsing Rao, Assistant Manager, Telangana State Industrial Development Corporation (TSIDC), Hyderabad with regard to discrimination in promotion

(File No. MNR/3/2015/STGTL/SEPROM/RU-IV)

- 2. After welcoming the participants and their introduction, the petitioner was asked to explain his grievance.
- 3. The petitioner M. Narsing Rao has submitted before the Commission that he was working as Assistant Manager in TSIDC Ltd and he was promoted to post of Deputy Manager by relaxing the qualification. However the Corporation Administration has not followed rules of reservation in promotion of ST candidates as he was eligible to be considered for promotion to the post of Assistant Manager w.e.f 2004 and to the post Deputy Manager w.e.f 2009 with consequential benefits. The Board of Corporation considered his promotions and recommended Govt. of Telangana. However his promotion to the post of Assistant Manager was considered w.e.f 10-05-2012 and Deputy Manager w.e.f 20.10.2016 violating the rules of reservation.

He then approached to the Hon'ble NCST and requested for intervention in the matter. Accordingly the Hon'ble Commission took his case with TSIDC management and subsequently, a sitting was held on 02.11.2016 in the Commission. The Commission had recommended that the DPC from 2004 for the post of Assistant Manager be reviewed and he be given promotion as per his eligibility and criteria. Similarly the promotion for the post of Deputy Manager w.e.f 2016 be also reviewed. TA/DA as per rules for attending the sitting in the Commission be also provided. But none of the Commission's recommendations have been complied with.

- 4. The CMD, TSIDC has apprised the facts of the case and also reported that the Corporation has taken a liberal view in the petitioner's promotion and after relaxing the eligibility criteria of having Graduate Degree, he was promoted to the post of Assistant Manager vide office proceedings dated 10.05.2012. Further, he was also promoted to the post of Deputy Manager w.e.f 20.10.2016 by duly following rules of reservation. Thus, the Corporation has extended all the eligible benefits to the petitioner.
- 5. The case was discussed in detail. The Commission observed that no rules of reservation in promotion for ST's has been followed. The Commission recommends that the Principal Secretary, Industries & Commerce Department Govt. of Telangana and the Joint Managing Director, Telangana State Industrial Development Corporation (TSIDC) may consider promotion of Shri M. Narsing Rao, Assistant Manager (Retired) as per RoR and approved note of the Vice Chairaman & Managing Director, Telangana State Industrial Development Corporation (TSIDC)
