2.After welcoming the participants and their introduction, the petitioner was

asked to explain his grievance.

3. It was stated before the commission that the four persons, namely, Ex Surpanch K Chandra Reddy, K Krishna Reddy, Jalalpuram Reddy and Pannalal Bal Reddy have been torturing and abusing on caste grounds. They have damaged his house and threatened him to kill him and his family. On his complaint to the police, they were also arrested. Police has filled a charge sheet i and the trial is going on. Now they have been released on bail and have again started harassing him.

4. The Additional Collector and the Dy S P appeared before the Commission.

5. The Commission recommends to the District Collector and Superintendent of Police to intervene and ensure the safety of the petitioner and his family and an action taken report be submitted to the Commission.
