- 2. After welcoming the participants and their introduction, it was noted that the petitioner was not present. Hon'ble member decided to hear the officers of SECL.
- The petitioner Dr. Dinesh Singh, Ex-Medical Superintendent, SECL, Ramnagar (MP) submitted before the Commission that he was awarded major punishment of demotion by two grades for period of 3 years vide SECL letter dated 11.03.2006 alleging that he had attested the medical certificate of Smt. Terasia Bai, w/o late Shri Hetram for compassionate appointment as she was not medically fit for appointment. However, the fact was that the Personnel Department of SECL had prepared the employment file of Smt. Terasia Bai and after due approval, it was sent to medical department for medical examination of the applicant. Thereafter, the senior Medical Officer Shri V.G. Misra and his staff has conducted medical examination of the applicant. His role in the matter was that he had signed on the medical certificate prepared by the Senior Medical Officer. It is further informed by the petitioner that Smt. Terasia Bai was not wife of Shri Hetram, deceased employee of SECL. It was the duty of the Personnel Department and Senior Medical Officer to check the document of Smt. Terasia Bai and there was no role of the petitioner. No Departmental inquiry was conducted and he was not given due opportunities to defend his case. In addition, the Personnel Manager who prepared the Smt. Terasia Bai file took huge amount as bribe and no action was taken against the Personnel Manager and the Senior Medical Officer of the SECL, Hasdev Area. He requested for exoneration from the charges.
