2. After welcoming the participants and their introduction, the petitioner was asked to explain his grievance.

- 3. The petitioner submitted regarding denial of appointment to the post of Assistant General Manager (General Administration). The petitioner further stated that he is the General Secretary, FCI Employees Welfare Association, Hyderabad and he applied for the post of Assistant General Manager (General Admn) in the year 2009. He cleared written examination and group discussion for the post. Thereafter, at the time interview, he was given 02 marks out of 20 marks. Thus, he was denied appointment being member of ST community. In addition, he was also harassed in transfer. In this regard, he was transferred from AP region to Karnataka Region on 07.03.2013 and relieved from duty on 10.10.2013 to join at transferred place. He made request and his transfer was cancelled on 31.07.2014. The FCI forcefully taken leave application for 10 months from him. He requested for regularization of 10 months period on duty.
- 4. The absence of CMD, FCI was noted. The officers of FCI could not satisfactorily replied to the queries of the Commission. The Commission decided to hear the CMD, FCI in the matter in another meeting. In the meanwhile, the Commission recommends that the status of backlog/ shortfall vacancies in ST category be submitted to the Commission.
