- 2. After welcoming the participants and their introduction, the petitioner was asked to explain his grievance.
- 3. The petitioner submitted grievances of non-implementation of Rule of Reservation in DPS workers appointment and DDEQ appointment. It has been alleged that the FCI management has not implemented recommendation of Director, NCST, Jaipur regarding regularization of service of DPS workers and implementation of Reservation Policy. The FCI management has also not considered any ST candidate for compassionate appointment despite 74 DDEQ quota appointment for DPS labourers from the year 2007 to 2014 by FCI, RO, Hyderabad. He requested for appointment of Shri D. Hatiram under DDEQ quota.
- 4. The Executive Director in FCI explained that induction of the five persons before the petitioner was due the priority was to be given to those who died on the spot of duty. It was also clarified that none of the 12 persons has so far been employed. The process of employment has, however, been stayed by the High Court. He assured that on vacation of the court stay, the petitioner will certainly get the job.
- 5. The Commission recommends to the FCI to approach the Hon'ble High Court requesting for the early gearing. The action taken report may be submitted to the Commission.
