- The petitioner stated that the tribal land was grabbed from the STs by the non STs through application of Tenancy Act in tribal areas and the construction activity is going thereon, which is illegal and immediately be stopped.
 - The Officer of the State Govt could not give satisfactory answer. The Commission observes that Tenancy Act cannot apply to the tribal land. The construction activities should immediately be stopped. Compliance report should be sent within 15 days. The Commission
