Minutes of sitting held in the NCST's Headquarters on 14/02/2020 at 01:30 PM under the Chairmanship of Dr.Nand Kumar Sai, Hon'ble Chairperson, NCST in the case of Shri T. Chakravarthy, (R/o 42-64-34, Block No- 13, Ajith Singh Nagar, Vijaywada) Chief Ticket Inspector, Vijaywada Division regarding humiliation in posting by South Central Railway.

Shri T. Chakravarthy, (R/o 42-64-34, Block No- 13, Ajith Singh Nagar, Vijaywada) Chief Ticket Inspector, Vijaywada Division vide representation dated 01.07.2019 is aggrieved regarding humiliation in posting by South Central Railway and requested for justice. The NCST's vide letter dated 29.08.2019 has referred the matter to General Manager, South Central Railway, Secunderabad and Divisional Railway Manager, Vijaywada Division, South Central Railway, Vijaywada for facts and comments followed by reminder dated 10.12.2019. The South Central Railway, Secunderabad vide letter No. SCR/P.HQ/622/RP/NC(ST)/AS dated 19.12.2019 had forwarded the copy of their letter dated 17.10.2019 intimating the facts and stated that Shri Ch. Vidya Sagar, CTI work as stand by Supervisor at times of exigencies. As such the allegation of Shri T. Chakravarthy, CTI that he is humiliated on caste lines is untrue.

- 2. The Hon'ble Chairperson had fixed the sitting on 14.02.2020 at 01.30 PM to discuss the matter with the officers of South Central Railway and petitioner. The sitting notice was issued on 31.01.2020 to General Manager, South Central Railway, Secunderabad and Divisional Railway Manager, Vijaywada Division, South Central Railway, Vijaywada and petitioner. The General Manager, South Central Railway vide DO letter No. SCR/P-HQ/622/RP/NC(ST) dated 10.02.2020 had sought exemption to appear before the sitting due to preoccupied business and deputed Additional Divisional Railway Manager, Vijaywada and Sr. Divisional Personnel Officer, Vijaywada Division.
- 3. In the sitting, officers from South Central Railway and petitioner were present. The Hon'ble Chairperson, asked the petitioner about his grievance and asked the Railway authority to respond. The petitioner informed that the junior person posted in supervisory post, which is against the rule. The Hon'ble Chairperson asked the representatives of South Central Railway to explain the action taken by them. The representative of South Central Railway was unable to give satisfactory reply.
- 4. After detailed discussion with the representatives of South Central Railway and petitioner, the Hon'ble Chairperson recommended that the petitioner should be appointed as supervisor by the DRM, Vijaywada Division as per rules, if he is senior to other CTI. The action taken report in the matter may be submitted to the Commission within one month.
