- 2. After welcoming the participants and their introduction, the petitioner was asked to explain his grievance.
- 3. The Petitioner explained his case and referred to hearing of 30th Dec., 2019 wherein the Commission recommended that the status of backlog/shortfall vacancies in ST category be submitted to the Commission.
- 4. The ED explained to the Commission that in 2008, the vacancies as advertised in 2005 were re advertised and accordingly those vacancies were filled up as per result of that exam. Therefore, the petitioner's claim is not justified as all the backlog vacancies were filled up.
- 5. The Commission observes that the FCI should look into the matter sympathetically as the petitioner missed the opportunity by a narrow margin.
- 6. The Petitioner was also advised to submit related document pertaining to the backlog vacancies of AGM, (GA) to the Commission and also to the FCI. The Commission further recommends to the FCI to submit a para wise ATR to the Commission within 10 days.
