- 2. After welcoming the participants and their introduction, the petitioner was asked to explain his grievance.
- The petitioner Shri Sambavath Lakpathy, Saroornagar, Hyderabad 3. represented before the Commission that he is working as Officer MM-III grade in State Bank of India, Hyderabad. During his service, he got 3 promotions based on the hard work and sincerity. While working as Branch Manager at SBI, Shamsheerguni Branch, Hyderabad, he was issued suspension order vide order dated 14.06.2019 without any issuance of any charges by the SBI management and his suspension has not been revoked so far. No chargesheet has also issued against him. He is still under suspension for last 8 months. He has requested the Bank management to revoke his suspension but no action has been taken. The Hon'ble Commission has requested to issue necessary direction to the SBI management for immediate revocation of his suspension order. He also added that in similar cases in Banjara Hills branch the bank didi not take any action against those officials whereas he has been victimized for being an ST.

The General Manager stated that the petitioner issued 106 sanction letters granting educational loans from his official e mail id and also sanctioned a number of personal loans beyond his authority. The inquiry is in the process which is likely to be concluded in 3-4 weeks' time. The bank has taken all the precautions as per rules.
- 5. The Commission observes that matter needs to be examined by an expert and recommends to the bank to submit all the necessary papers to the Commission. A report of the officials involved in Banjara Hills branch case also be submitted to the Commission. The Commission further recommends that pending the outcome of the Inquiry, the petitioner be reinstated and if necessary be posted to a non-sensitive post.
