Sub: Proceedings of the Sitting held under the Chairmanship of Hon'ble Vice Chairperson, NCST, to discuss the case of Shri Dharamsingh Meena, APO, NWR regarding selection for promotion to the Group 'B' post of Assistant Personnel Officer in the Northern-Western Railway.

Date of Sitting: 17/06/2016 at 1200 Noon.

List of participants in the Sitting is as at Annexure A.

A representation was received in the Commission from Shri Dharamsingh Meena, APO, North Western Railway regarding selection for promotion to the Group 'B' post of Assistant Personnel Officer.

The matter was taken up with, Railway Board, Ministry of Railways vide this Commission's letter dated 11/03/2016. No reply was received from the Department, Hon'ble VC, NCST fixed a Sitting to discuss the matter with Chairman, Railway Board, Ministry of Railways on 17/06/2016.

Chairman, Railway Board vide their letter dated 14/06/2016, has deputed Shri Anil Singhal, General Manager, Head of North Western Railway Administration to appear before the Commission. The petitioner Shri Dharamsingh Meena was asked to explain his case. Shri Meena reported that he was not considered for promotion to the post of Assistant Personal Officer, Group "B" by the Northern Western Railway, Department of Personnel according to advertisement dated 21/03/2011 against the reserved post of ST.

The General Manager submitted that Shri Ram Chandra Meena was transferred in NWR from the Western Railway and accordingly he was promoted to the post of APO under ST category in NWR.

General Manager stated that notification for selection of APO (regular) for filling up of the posts against regular selection was notified on 21/03/2011, 13 employees were declared qualified against written examination in which Dharamsingh Meena was also appeared at Sr. No. 5 in the order of Seniority. Later on due to complaints in the said selection the Vigilance Department inquired into alleged regularities. Thereafter the matter was re-examined by the re-constituted SAG level Selection Committee appointed by the Competent Authority. The Committee recommended that none of the candidate has qualified to be called for the viva-voce test. Shri G.L. Meena and Shri Deepak Peter have been issued minor penalty as advised by the Central Vigilance Commission.

General Manager further stated that answer sheet of Shri Dharamsingh Meena for the said selection has already been re-checked/taken care by the selection committee. Therefore, allegation made by Shri Meena does not found merit.

Having heard the above, Hon'ble Vice-Chairperson advised that position of the case of transfer / promotion of Shri Ram Chandra Meena to the post of APO may be obtained from Western Railway and send to the Commission for further examination.

The Sitting ended with the vote of thanks to the chair.
