- 1. A Sitting was held in the Conference Room of NCST on 22/09/2016 under the Chairmanship of Hon'ble Vice Chairperson, NCST to discuss the matter as mentioned above.
- 2. List of participants in the Sitting is as at Annexure A.
- 3. Smt. Sangita Kanaujia, Deputy Collector, Haridwar has attended the sitting without any official authority letter and has requested for exemption of the presence of Commissioner and Secretary, Govt of Uttarakhand. Hon'ble Vice Chairperson has allowed representing the case.
- 4. Hon'ble Vice Chairman wanted to know from Smt. Sangita Kanaujia whether she is competent to take any decision during course of the meeting in this particular case. Smt. Sangita replied that she is not competent to take any decision on behalf of the Govt. of Uttarakhand or DC, Haridwar.
- 5. Director (Admn.), NCST has explained that no reply so far has been received from the State Govt.
- 6. During discussion the Hon'ble Vice Chairperson has directed the petitioner to present his case, before the Commission.
- 7. Petitioner (Shri Gopal Singh) has explained his case and also requested for his transfer to Rourkee due to his health problem and stated that he was demoted from the post of 'Tehsildar' to 'Upper Tehsildar'. Smt. Sangita Kanaujia,

Deputy Collector has explained that the scale of 'Teheseldar' and 'Upper Tehsildar 'are the same.

- 8. He has stated that he has completed only one year at Rourkee and has been transferred as he has filed a petition in the National Commission for Scheduled Tribes. The petitioner is within 3 years of his retirement on superannuation. Government instructions are there to retain a Govt. servant who is nearing retirement.
- 9. Sh Gopal Singh also stated he has been superseded by his junior and has been placed as Tehsildar by the State Government, which has been viewed seriously by the Commission as has ACR reports are found to be above the bench mark.
- 10. Hon'ble Vice Chairperson has directed to issue summons to Chief Secretary, Govt. of Uttarakhand for a sitting on 20.10.2016 at 13.00 Hour, as no responsible officer attended the hearing on 22.9.2016 and no reply has been received from Government of Uttarakhand.

11. The Sitting ended with the vote of thanks to the chair.
