Proceedings of the Sitting taken by the Vice-Chairperson, NCST on 30.08.2016 in the matter of Shri PKJP Singh, C/o 56 APO regarding promotion. .

Date of sitting: 30.08.2016

Representation received from Shri PKJP Singh, Assistant Executive Engineer, Border Roads Organisation regarding a request for early finalisation of departmental enquiry and promotion to the post of Executive Shri PKJP Singh joined BRO on 2/8/2004 under an exam conducted by UPSC. He was charge sheeted on 27/02/2014 for alleged acceptance of smaller stone boulders thereby giving undue benefit to the contractor during his duties as Engineer-in-charge. An enquiry was conducted. In the preliminary enquiry the investigation officer confirmed that stone boulders were procured as per IRC guidelines and in the final orders on the departmental enquiry dated 13/4/2015 he was exonerated, with just a warning. Despite receiving the final orders of the departmental enquiry he had not been promoted to the post of Executive Engineer., whereas his juniors have already been promoted to the posts of Executive Engineers (Civil).

On perusal of the matter, the Commission decided to take up his case for a hearing and The Secretary, Border Roads Development Board was called for a sitting to be held at the Headquarter of the Commission on 30/08/2016 at 12 noon to resolve the matter and address the grievance of the petitioner. The petitioner Shri PKJP Singh was also called for the sitting.

- 3. In the sitting the respondents explained that the name of Shri PKJP Singh was first considered for promotion to the post of Executive Engineer (Civils) by the DPC for the panel year 2012-2013. However, since he was yet to get a vigilance clearance at that point of time, the DPC recommendations were kept in a sealed cover as per Government guidelines.
- 4. No DPC was held in the year 2013-2014. Owing to non-availability of vacancies. In the DPC held for the year 2014-2015 also the recommendations of DPC were kept in a sealed cover because he is yet to be exonerated from his charges. However, DGBR vide memorandum dated 13/04/2015 had only issued a warning to Shri PKJP Singh. In view of the above, Shri PKJP Singh requested for opening of the sealed cover vide his representation dated 24/05/2015. The respondents maintained that the case of Shri PKJP Singh was a justified case and his grievance would be redressed within 4 months, considering the fact that he has been suffering for the past few years. He also added that the case would be resolved within 15 days.
- 5. Commission has seen that the case of promotion of Shri PKJP Singh has been delayed for no reason and therefore advises BRDO to see to it and the promotion is granted at the earliest.
