Proceeding of the Sitting held by Shri Ravi Thakur, Vice Chairperson, NCST on 20.10.2016 in the case of Shri Lalan Sah, Assistant Manager, BSNL regarding his promotion w.e.f. April 2010.

Pursuance to the proceedings of the Sitting held on 31.05.2013, 16.01.2015, 29.04.2015 and <u>D.O.No</u>. VC/NCST/2016/1179 dated 12.01. 2016 in the matter vide which Commission advised BSNL to issue necessary orders for giving relief to the petitioner Shri Lalan Sah and for intimating the Commission, the NCST has not been informed of the status of action taken and the petitioner has informed the Commission that BSNL has not issued any such order. Consequently, a Sitting was convened on 20.10.2016.

During the Sitting, the Commission noted that petitioner Shri Lalan Sah has given promotion in the grade of UDC with effect from 01.07.2004 but the promotion order was issued on 31.03.2010 i.e. after a gap of approximately 6 years. In the meantime Departmental examination for promotion to the grade of Assistant Manager was held on 10.01.2010. No action has been taken by the BSNL on the request of Shri Lalan Sah for allowing him to appear provisionally at the Departmental Examination held on 10.01.2010.

The Commission noted that, great injustice has been done in this case by BSNL to the petitioner Shri Lalan Sah by depriving him the opportunity to appear in the Limited Departmental Competitive Examination held on 10.01.2010 although he was eligible and completed 5 years' service in the grade of UDC on 30.06.2009. Shri Lalan Sah appeared in the next LICE 2011 in which he was declared qualified and was promoted to the grade of Assistant Manager.

The Commission further noted that, during all the previous sittings BSNL took different stands and their stand was contradictory. The case of Shri Lalan Sah has arisen due to negligent attitude on the part of BSNL in deciding the cases expeditiously as they have not issued the promotion orders in the grade of UDC in time and also not allowed to appear in the LICE to the grade of AM held on 10.01.2010 even on provisional basis.

The National Commission for Scheduled Tribes is of the view that grave mistake has been committed by BSNL by not deciding the issue at the appropriate time thereby denying genuine chance to an eligible candidate to appear for the Limited Departmental Examination. Hence the petitioner deserves to be granted promotion against the vacancy for which LICE 2010 was held and recommends that keeping in view the above facts and those brought out in the previous sitting, the BSNL may issue orders for promotion of Sh.Lalan Sah as AM on notional basis with notional pay fixation w.e.f. April, 2010 i.e. the date from which other successful candidates of LICE 2010 were appointed as AM. A copy of the order issued by BSNL may be furnished to the National Commission for Scheduled Tribes within 15 days.

The sitting ended with a vote of thanks to the Chair.
