Ramakrishna Naik, Bode Naik Thanda (Village), Chippala Madugu (Post), Via Kutagulla, Kadiri (Taluk), Ananthapuram Dist., (Andhra Pradesh) regarding construction of B.T. Road from Ramadas Thanda, Bode Naik Thanda and Meete Naik Thanda connecting to Gollolla Cheruvu, Yerra Doddi (Panchayat Hqs) and Kotha Palli Villages, a Sitting was fixed by Hon'ble Vice-Chairperson on 01.11.2016 at 3.00 P.M. to discuss the issue with the Chief Secretary, Government of Andhra Pradesh.

- The Hon'ble Vice-Chairperson called Shri J. Ramakrishna Naik, Petitioner to 4. discuss the matter before the time i.e. 3.00 P.M. allotted for the Sitting to discuss his

- 5. The Principal Secretary, Tribal Welfare Department, Govt. of Andhra Pradesh informed that the Tribal Welfare Department vide G.O.Rt. No. 351 dated 28.10.2016 had accorded the sanction for the road work "BT Road from Ramdas Thanda, Bode Naik Thanda & Meete Naik Thanda connecting to Gollalla Cheruvu Villagae, Yerradoddi (Panchayat HQs) and Kothapalli Villages with an estimated cost of Rs. 4.40 Crs in Ananthapur District from the TSP funds allocated to the Panchayat Raj Department. In the Sitting a copy of this letter was provided to the NCST and the petitioner by the Principal Secretary, Tribal Welfare Department, Govt. of Andhra Pradesh.
- 6. The Hon'ble Vice-Chairperson appreciated the action taken by the Tribal Welfare Department, Govt. of Andhra Pradesh. Since the case is successful and decided to close the case.
