- 3. The Secretary, Commerce sought exemption and deputed Additional Secretary and other Officers of the Department as well as Secretary, Spices Board for attending the Sitting.

- 5. The Additional Secretary pointed out that the issue of promotion of Shri Shri Hanmanthu was discussed in the Sitting of the Commission held on 02.09.2015. As per advice of NCST, Shri Hanmanthu promoted to the post of Section Officer and posted at Warangal.
- The Hon'ble Vice-Chairperson directed Shri Hanmanthu to explain his grievances. Shri Hanmanthu has stated that a new post of Director (IPR) may be created, as per IPR.
- The Additional Secretary explained that there is no post of Director (IPR) in Spices Board, neither there is requirement of such exclusive post of Director level.
