Petitioner was not satisfied with their reply and has sent a rejoinder 15/05/2017 to this Commission. Therefore, Shri Harshadbhai Chunnilal Vasava, Hon'ble Member, NCST has desired to discuss the matter in person with you and accordingly fixed a sitting on 08/06/2017 at 11:30 A. M. in the Commission at Conference Room, 6<sup>th</sup> floor, Loknayak Bhawan, Khan Market, New Delhi for investigation / inquiry / action taken in the matter in pursuance of the powers conferred upon it under Article 338A of the Constitution of India. You are also hereby requested to submit the facts and information with details on the day of sitting.

Please take notice that in case you do not attend the Sitting with details, the Commission may exercise the powers of Civil Court conferred on it under Article 338A of the Constitution of India and issue summons for your appearance in person or by a representative before the Commission.
