In pursuance to the discussion held in the matter on 22.03.2017 and on examination of the reply of Air India dated 03.112016 Hon'ble Vice-Chairperson, desired to discuss the matter with CMD, Air India and fixed up a Sitting on 22.03.2017. Hon'ble Vice Chairperson also desired that Air India may also bring the status of all the pending cases (as per list attached).

A letter dated 20.03.2017 of CMD, Air India was given by the Air India officers on 22.03.2017 that due to prior commitment CMD was not able to come for discussion and deputed the officers of Air India to appear before the Commission. The Commission took serious note of it and asked the officers of Air India that communication has been received during of Sitting whereas sitting notice was sent to CMD on 06.03.2017. Air India may honour the Constitutional Body in full filling its mandate.

Shri Jameel Ahmed Choudhary was given opportunity to explain his grievance before the amongst please.

On hearing the petitioner and Air India Authorities, Commission noted the followings.

- That Air India advertised 197 post of Sr. Trainee Pilot (A 320 endorsement) in February, 2015 out of which 13 post were reserved for STs out of which 78 candidate were selected of which 1 STs was selected.
- ii. That again in August, 2015, 180 vacancies for CPL holders were advertised and 68 candidates were selected of which 2 were STs candidate.
- iii. In October-November 534 vacancies for Sr. Trainee Pilot (A 320 endorsement) were advertised and 46 were reserved for ST candidates whereas 124 were selected

out of which 1 was ST. That again in June, 2016, 415 vacancies Sr. Trainee Pilot (A 320 endorsement) were advertised and 45 were reserved for STs and out of which 160 got selected and for 4 were ST candidates and stand by list is also maintained in respect of general category candidates only.

- 2. That in the Sitting held on 10.11.2016 proceeding were issued.
- 3. That vide letter No. HPD01/W-dated 20.12.2016 Air India intimated "out of selection/recruitment exercise for the CPL holders/type rated pilots very shortly exclusively for the ST candidates taking into the consideration the backlog of ST post. This will give an opportunity to Mr. Jameel Ahmed Choudhary to appear for his selection in the Said category of post. Mr. Jameel Ahmed Choudhary did not qualify in the written test in the selection exercise held on 11.10.2016 and subsequently did not qualify in the psychometric test in the selection exercise held in July 2016".
  - 4. That Air India has a backlog of reserved posts for STs.

#### Conclusion

5. Commission noted and advised Executive Director(Pers.) to fill up the backlog of ST reserved posts by launching Special Drive. ED (Pers.) assured that Air India will launch special drive for Scheduled Tribes and complete the entire process within 45 days on the lines of selection/recruitment process followed in the last recruitment, with simulator check, followed by personal interview. It was also advised to submit the original reservation Roster maintained by Air India for Pilots for examination of the Commission.
