Pursuance to the Sittings held on 20.02.2015 and 25.05.2015 in the matter of Shri Hari Shankar Meena, Karauli, Rajasthan vide letter dated 27.07.2015 SSC has enclosed a copy of letter dated 10.07.2015 asking DoPT to sympathetically consider the case.

> "The National Commission for Scheduled Tribes heard the case on 25th May, 2015 and recommended that SSC may promptly take up the matter with DoPT and obtain approval for extension of joining time as a special case and forward the approval to the Commissioner, Central excise, Chennai for further necessary action. In view of this, the extension may be considered as a special case which should not be quoted as a precedent in future."

2. To discuss the case on 02.09.2015 the Chairman, Staff Selection Commission and the Joint Secretary, Department of Personnel & Training appeared before the Commission. The Issue of granting extension to Shri Hari Shankar Meena was re-discussed and DoPT submitted that OM No. 35015/2/93/Estt(D) dated 09.08.1995 has been followed and in the light of above OM Shri Hari Shankar Meena was given extension for the period of three months from 01.01.2014 to 31.03.2014 and second extension from 01.04.2014 to 03.06.2014. He was to join on 04.06.2014 but

requested CBEC for extension of 12 days i.e. 04.06.2014 to 15.06.2014 and as per above OM an offer of appointment would lapse automatically after expiry of 6 months from the date of original offer of appointment.

- 3. The petitioner who was present said there are instances/cases where other candidates have been given extension beyond six months by CBEC. Petitioner placed RTI records before the Forum.
- 4. Hon'ble Vice-Chairperson advised the petitioner to give representation with supportive documents obtained by him under RTI in this regard. DoPT will examine the cases of such extension beyond six months in consultation with Central Board of Excise and Customs.
- 5. DoPT will send the Examination Report by 15th October, 2015 to the Commission for further action .
