
A representation dated 26/02/2014 was received from Smt. Anju Kataria, W/o Manoj Kataria, R/o C-21, Ambabardi, Jaipur, Rajasthan regarding irregularities in the allotment of petrol pump outlet of IOCL.

The matter was taken up with the CMD, IOCL vide this Commission's letter dated 07/03/2014. In response to the Commission's above letter, the DGM (Retail sales), IOCL replied vide their letter dated 04/04/2014 that Jaipur, Divisional Office vide letter dated 24/12/2013 had requested District Supply Officer, Jaipur District for doing the needful in the matter. No information about action taken in the matter has been received from the IOCL further.

Shri Harshadbhai C. Vasava, Hon'ble Member, NCST has fixed a sitting to discuss the matter with the Chairman, IOCL on 18/05/2017 at 11:30 A.M.

Shri S. Mukherjee, Executive Director (HR & CSR), Shri K. Vijay, Executive Director, HRD and Shri S. K. Bose, GM (HRD), Indian Oil Corporation Ltd. appeared before the Commission on 18/05/2017. The matter was discussed in details. The IOCL authority submitted a letter no. NCST/RSO dated 15/05/2017 to the Commission and apprised that District Supply Officer, Jaipur had issued the license on 22/04/2014 and Smt. Anju Kataria, commenced operation of the retail outlet on 01/05/2014. Hence, grievances of Smt. Anju Kataria has been redressed.

The Commission expressed its appreciation to IOCL for allotting the Retail Pump Outlet to Smt. Anju Kataria.
