Minutes of sitting held in the Commission on 29/06/2017 at 11:30 A.M. under the Chairmanship of Shri H. C. Vasava, Hon'ble Member, NCST in the case of Shri Fogatbhai Ravjibhai Vasava regarding re-allotment of the land acquired by Govt. having survey no. 206 – 1, 1881203, 195-1 of village Jeetnagar, Taluka – Nanded, District – Narmada or allotment of any other Land in lieu of the acquired land.

A representation dated 13/02/2017 was received from Shri Fogatbhai Ravjibhai Vasava regarding re-allotment of the land acquired by Govt. having survey no. 206 – 1, 1881203, 195-1 of village Jeetnagar, Taluka – Nanded, District – Narmada or allotment of any other Land in lieu of the acquired land.

The matter was taken up with the Secretary, Govt. of Gujarat and District Collector, District Narmada, Gujarat vide this Commission's letter dated 14/03/2017 for necessary action. No reply was received from the Department, therefore, the Hon'ble Member (HCV) has fixed a sitting for discussion in the matter on 09/06/2017 with the Secretary, Govt. of Gujarat and District Collector, District Narmada, Gujarat. But no officials attended the sitting.

The Hon'ble Member (HCV) has fixed another sitting with the Secretary, Govt. of Gujarat and District Collector, District Narmada, Gujarat on 29/06/2017 at 11:30 A.M.

Discussion:

Shri D. N. Chaudhary, Deputy Collector, District-Narmada, Gujarat appeared before the Commission on 29/06/2017. The matter was discussed in detail. Hon'ble Member asked the Deputy Collector to settle the case of tribes. The Deputy Collector submitted to the Commission that land of ST families was acquired in the year of 1984 in the Baruch District. At present the said issue come under the jurisdiction of newly created district Narmada. The affected ST families are still cultivating on said land for their livelihood. He has apprised that Hon'ble Supreme Court ordered to give land in lieu of land acquired from the applicant. The Deputy Collector also informed that the process of identification of agriculture land is going on and it will take some time. The Hon'ble Member after hearing both parties, suggested that all work relating to compensation / providing land in lieu of acquired land to scheduled tribes families may be completed within two months and report furnished to this Commission. It was also decided that another sitting will be held with the Secretary, Revenue Department, Govt. of Gujarat and the District Collector, District Narmada on 29/08/2017 at 12:00 Noon in the matter.
