Representation dated 25/03/2017 received from Shri Nansingh J. Vasava, Gujarat Maritime Board, Station Road, Near Hotel Padru, District-Bharuch, Gujarat - 392001 regarding injustice with ST Officers and employees of Gujarat Maritime Board.

The matter was taken up with the Chairman, Gujarat Maritime Board vide this Commission's letter dated 06/04/2017 for necessary action. No reply was received from the Department, therefore, the Hon'ble Member (HCV) has fixed a sitting for discussion in the matter on 09/06/2017 with the Chairman, Gujarat Maritime Board. The Vice- Chairman and CEO, Gujarat Maritime Board furnished a reply dated 25/05/2017 and exemption letter for personal appearance of Chairman, Gujarat Maritime Board in the Commission and deputed Shri Hasmukh J. Prajapati, OSD. The petitioner did not appear in the sitting.

The Hon'ble Member (HCV) has fixed a further sitting with the Chairman, Gujarat Maritime Board on 29/06/2017 at 12:00 Noon. Shri Hasmukh J. Prajapati, OSD to Chairman, Gujarat Maritime Board appeared in the Commission on the scheduled sitting. The matter has discussed at length. The OSD to Chairman, Gujarat Maritime Board apprised to the Commission that promotions / appointments given to all employees / Officers of Scheduled Tribes in Class I, II, III & IV are done as per eligibility criteria. Allegation made by the complainant is meaningless and baseless.

After going through the report of the Gujarat Maritime Board which indicates that 25 posts of different levels are filled by ST people, the Commission felt that ST employees are not treated unfairly and accordingly, the case was treated as closed.
