Whereas Petitions / Complaints have been received by the National Commission for Scheduled Tribes from Shri Arvind Kumar Gond dated 23/03/2017 and 31/03/2017 (copies enclosed) and to say that a D. O. letter from the Secretary, NCST has been sent to the Chief Secretary, Uttar Pradesh on dated 13/04/2017 (copy enclosed). In response to the above D. O. letter of the Commission, no Action Taken Report was received from the Office of the Chief Secretary, Uttar Pradesh.
