Minutes of the sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi, in the case of Smt. Banoth Amala W/o Ram Koti Naik, Dharavath Thanda Village, Devaruppula Mandal, Jangoan District, Telangana Lodged ST Atrocities Act Complaint on 12.10.2020-praying for Justice

Smt. Banoth Amala, Village-Dharavath Thanda, Devaruppula Mandal, Jangaon District, Telangana, has alleged harassment and life threats from Sri Shobanaboina Shivaraj Yadav and his associates, despite owning a legally purchased and documented 600-square-yard house site in Jangaon. She claims that, after obtaining the necessary municipal permissions, her house construction was obstructed multiple times through physical intimidation, verbal abuse and threats, including castebased slurs targeting her as a member of the Lambada Scheduled Tribal (ST) community. Despite securing interim injunction orders from the court to continue construction, she alleges that the police have failed to take action against the accused, even after lodging an ST Atrocities Act complaint on October 12, 2020 and subsequent reminders to various officials. She has sought the intervention of the National Commission for Scheduled Tribes (NCST) to ensure justice and protection of her property.

2. The same matter was dealt by NCST in file bearing no . NCST /ATY-455/TS/21/2022-APCR. In this matter, a sitting was held on 27.1.2025 and the minutes in which the following recommendations were made forwarded to concerned authority. Thereafter, minutes have also been forwarded to District Collector, Warrangal and Commissioner, Municipal Corporation, Warangal

The Municipal Commissioner and District Collector may ensure that the survey on the disputed land
may be immediately conducted, the boundaries of the claimants to be demarcated, and petitioners land
to be identified with clear boundaries in 15 days.

 All the link documents of each of the claimant's on the disputed land for the parcel of land claimed by them to be verified along with the maps.

The District Collector, Municipal Commissioner, District Registrar of Registration and Stamps Department and Deputy Commissioner of Police to attend the next scheduled date of hearing.

Hon'ble Member, NCST has decided to discuss the issue with the authority and the petitioner on 04.03.2025. Accordingly, a Sitting Notice was sent on 1 24.02.2025 to District Collector, Jangaon.
 Meanwhile, in response to NCST communication of file bearing no. NCST /ATY-455/TS/21/2022-APCR, the Municipal Commissioner, Jangaon vide letter no. MCJ/G1/555/2023 dated 24.2.2025 addressed to Tehsildar, Jangaon and Asst. Director of Survey & Land Records, Jangaon and copy endorsed to NCST has furnished the facts. A speaking order no. MCJ/G1/555/2023 dated 12.7.2023 duly signed by Municipal Commissioner, Jangaon was also attached with the letter.
 In response to sitting notice dated 24.2.2025, the Collector & District Magistrate, Jangaon

vide letter no. C2/727/2022 dated 3.3.2025 has sought exemption and deputed Municipal Commissioner, Jangaon to attend the sitting. A copy of the report of physical inspection in file bearing no. A1/90/2025 dated 3.3.2025 duly signed by Municipal Commissioner, Jangaon and Assistant Director, Survey & Land Records, Jangaon attached with the letter.

6. In the sitting, Municipal Commissioner, Jangaon and petitioner's husband were present. The petitioner reiterated his earlier submission and requested for justice. The petitioner has stated that the survey was done for the namesake as Commission has insisted for it. The proper mapping is not done and it is merely mentioned that there is a variation in the parcel of land claimed to be sold and registered. The Municipal Commissioner, Jangaon stated that entire issue is a civil nature and already pursuing at Civil Court, Jangaon in various OS. The authority has further informed that the case is due for hearing in the Civil court of jangaon on 17th March after which it could be settled.

7. After discussion with the Municipal Commissioner, Jangaon and petitioner's husband, the following recommendations were made and action taken thereon may be furnished within 30 days from the receipt of the minutes.

a. The authorities may ensure that those who have sold the land may be held responsible for the mismatch.

b.District Collector Jangaon, The Commissioner of Police, Warangal, Municipal Commissioner, Jangaon and AD Survey Department may attend to the next scheduled date of hearing with complete details
