Accordingly, a sitting notice has been issued.

#### Discussion:

Shri N. B. Upadhyay, Registrar, Cooperative Society, Govt. of Gujarat, Gandhinagar appeared before the Commission on 04/10/2017. The petitioner Ms. Kanchanbhai Shanabhai Vasava was also present in the day of sitting. The matter was discussed in detail with the Registrar Cooperative Society, Govt. of Gujarat, Gandhinagar. During the discussion the Registrar submitted to the Commission that case of Ms. Kanchanbhai Shanabhai Vasava is under consideration and grievances of petitioner will be settled.

The Commission advised to the Registrar, Cooperative Society, Govt. of Gujarat that complaints of petitioner should be solved and also advised the petitioner to meet the Registrar Cooperative Society for redressal his grievances. The Commission also informed the petitioner that in case the Registrar is not cooperating and not attending to his grievances, he may again approach the Commission for redressal.
