Minutes of the sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi, in the case of Shri Sumit Kumar Meena, Organising Secretary, Dalit Bima Karamchari SC/ST Association, Narela, Delhi regarding discrimination against ST employees by NICL.

Date of the sitting: 05.03.2025 at 5:10 PM Participants in the Sitting - As per Annexure

Shri Sumit Kumar Meena, Organising Secretary, Dalit Bima Karamchari SC/ST Association, Pana Mamurpur, Narela, Delhi vide his representation dated 16.10.2024 has stated that the ST employees of National Insurance Company Limited (NICL) are being discriminated by the management of NICL (DRO2, NICL), by promoting other caste people and making them in-charge of different branches.

- 2. NCST vide Notice dated 28.1.2025 has referred the matter to CMD, NICL, Kolkata for facts and comments within 15 days. The Reply was not received, hence, NCST has decided to discuss the issue with the concerned authorities and petitioner on 05.03.2025. Accordingly, a Sitting Notice was sent on 21.02.2025.
- 3. The CMD, NICL, Kolkata vide letter dated 21.2.2025 has requested for exemption and deputed General Manager (HR) to attend the sitting. In the sitting, the General Manager (HR), NICL alongwith other officers of NICL and petitioner were present. In the sitting, the petitioner has reiterated their earlier submission and alleged that the management (DRO 2, NICL) is regulations of NICL for transfer and posting of the employees within the organization. A letter bearing no. HO/PERS/R6/2025 dated 4.03.2025 of NICL was also submitted during the sitting. The petitioner raised the problems of three employees namely Dr. Hanuman Meena (Emp No. (Delhi or Gaziabad) and Shri Sumit Kumar Meena (Emp No. 73158), for retention at DRO II. The petitioner has also given a representation containing the various problems related to welfare of STs (copy enclosed).
- 4. After discussion with the officers of NICL and petitioner, the following month from receipt of the minutes.

 The issue of retention of above employees at DRO II & IV (as mentioned above in para 3) may be considered by the NICL.
