Vasava, Hon'ble Member, NCST in the case of Shri Kiranbhai Chhotubhai Vasava, R/o 27 - Devasis Society, Mukkam Post - Vadiya, Rajpipla, District-Narmada, Gujarat regarding compassionate appointment.

A representation dated 12/02/2017 was received from Shri Kiranbhai Chhotubhai Vasava, R/o 27 - Devasis Society, Mukkam Post - Vadiya, Rajpipla, District-Narmada, Gujarat regarding compassionate appointment in the Panchayat Department.

The matter was taken up with the Principal Secretary, Panchayat Rural Housing and Rural Development Department, Govt. of Gujarat for taking necessary action vide this Commission's letter dated 14/03/2017. No reply was received from the PRHRD Department, therefore, Shri H.C. Vasava, Hon'ble Member, NCST has fixed a sitting on 07/06/2017 at 12:00 Noon in the matter. Accordingly, minutes of sitting has been issued to the concerned authorities vide this Commission's letter dated 21/06/2017 in response to minutes of sitting a reply dated 25/07/2017 has been received from the Panchayat, Rural Housing and Development Department, Govt. of Gujarat which has noticed not satisfactory. Therefore, a further sitting has been fixed by the Hon'ble Member (HCV) on 04/10/2017 at 2:30 P.M. Accordingly, a sitting notice has been issued to the concerned authorities.

#### Discussion:

Shri Raj Gopal, Principal Secretary, PRHRD Department, Govt. of Gujarat and Shri N. U. Pathan, Deputy Collector, Narmda appeared before the Commission. Matter was discussed in detail. The Hon'ble Member asked to the Principal Secretary for consideration of compassionate appointment to Shri Kiranbhai Chhotubhai Vasava on his personal income. The Principal Secretary assured to the Commission that matter will be looked at his level as a special case. The Commission advice that case of Shri Kiranbhai Chhotubhai Vasava should be considered in special manner since the petitioner belongs to Scheduled Tribe poor family and it is a very very old case being pursued by the applicant since very long time.
