

Minutes of the sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi, in the case of Smt. G.Manga, W/o Late Gogulothu Ravi, Ex-Technical officer, National Geophysical Research Institute (NGRI), Hyderabad regarding denial of compassionate appointment.


1. Smt. G.Manga, W/o Late Gogulothu Ravi, Ex-Technical officer, NGRI, Hyderabad submitted a representation dated 08.10.2024 wherein it is stated that her husband, who was working as Technical Officer at National Geophysical Research Institute (NGRI), Hyderabad died on 18.05.2021 due to Corona leaving behind his parents and children (One son and Two daughters). She requested for compassionate appointment as she is facing acute financial hardship to run her family. But so far no action has been taken by the NGRI.
2. NCST vide notice dated 29.11.2024 has referred the matter to Director, NGRI, Hyderabad for furnishing the facts and comments within 30 days from receipt of the Notice.
3. CSIR-NGRI vide letter dated 10.1.2025 has informed that the matter will be placed before the compassionate appointment committee in the month of Jan, 2025 to consider her case along with other pending application. The decision of the committee will be intimated as soon as the process is completed. This reply was forwarded to the petitioner on 15.01.2025 for information. There was no progress in the matter, hence, NCST has decided to discuss the issue with the concerned authority and petitioner on 04.03.2025. Accordingly, a Sitting Notice was sent on 21.2.2025 to all concerned.
4. In the sitting the Director, CSIR-NGRI, Hyderabad and petitioner was present. The Director, CSIR-NGRI, Hyderabad has reiterated its earlier submission made in their letter dated 10.1.2025 and informed the matter is under process.
5. It was observed that the action initiated by the NGRI is very slow and pending since last 4 years. The NGRI may take up the case on priority basis.
6. After discussion with the Director, CSIR-NGRI, Hyderabad and petitioner, the following recommendations were made and action taken thereon may be submitted to NCST within 45 days from the date of sitting.
 - The NGRI may expedite the process of pending survey and complete it in 45 days for consideration of the case of petitioner for compassionate appointment.
