Minutes of the sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi, in the case of Shri Sabavat Srinivas Naik S/O of Ramulu Naik, 3-14, Singammaguda tanda, Rajapur Mandal, District Mahabubnagar, Telangana regarding use of filthy language, harassment mentally and physically and attempt to murder the member of ST community.

NCST has received a complaint dated 29.11.2023 from Shri Sabavat Srinivas Naik S/O of Ramulu Naik, 3-14, Singammaguda tanda, Rajapur Mandal, Mahabubnagar District, Telangana. In the complaint he alleged that he is a National President of Sevalal Sena and belongs to ST community, he does good work for ST people because of that some people of upper caste threatened him, filed false cases against him and on 17th November there was a murder attempt on him by tipper. Shadnagar Police station didn't even take any action on his complaint, they just delaying the situation in the name of election. There are involvement of few upper caste persons and this murder attempt there are the involvement of Mahendar and CI Jamalappa. CI Jamalappa involved with Political leaders and business persons, he harassed petitioner physically and mentally abused him many times in the name of caste. Mahendar and CI Jamalappa are picturizing murder attempt as a fight between petitioner and Sabavath Balu so that they can get easy escape from the case

- In this matter, a sitting was held on 08.07.2024 at NCST. Thereafter, NCST has decided to discuss the issue on 5.3.2025 with the Commissioner of Police, Cyberabad, Hyderabad and petitioner. Accordingly, Sitting Notice was sent on 24.02.2025
- The Commissioner of Police, Cyberabad, Hyderabad vide letter dated 25,2,2025 has sought the exemption and deputed DCP, Shamshabad Zone and ACP Shad Nagar Division, Cyberabad to attend the sitting. In the sitting, DCP, Shamshabad Zone, ACP, Shad Nagar Division, Cyberabad and petitioner were present. The Police Officials has reiterated their earlier submission and provided a letter no. 198/OW/DCP-SZ/Cyb/2025 dated 5.3.2025 of DCP, Shamshabad Zone. In the letter, it has been stated that nearly 15 criminal cases were registered against the petitioner in in multiple police stations in Shadnagar, Peddapally, Rajendranagar, Balanagar. . The petitioner Sr. Srinivas Naik was arrested on 17.6.2024 in crime no. 390/2022 and 118/2024 of P.S Balanagar and sent to judicial remand and he was released on bail on 06.07.2024. The petitioner has reiterated his earlier submission and stated that the allegations leveled by are not correct. The petitioner further informed that all the cases on him are falsely registered and (13) cases are closed as false cases. It is alleged that CI Jamalappa has falsely picturized murder attempt as a fight between petitioner and Sabavath Balu.
- After discussion with the DCP, Shamshabad Zone and ACP, Shad Nagar Division, Cyberabad and petitioner, the following recommendations were made and the action taken report thereon may be submitted within 30 days from the receipt of the minutes.
- a. Call data records may be obtained from October 15, 2023 to November 25, 2023 to examine if there are any clues of involvement of CI Jamalappa Telecom Department may be consulted on this by the Police department.

b.The Status of investigation on the complaint sent to the DGP on the threat from Jamalappa and his involvement in the attemptive murder of the petitioner and the then SP, Mahabubnagar report on this may be obtained and submitted to NCST for further examination.
