## NATIONAL COMMISSION FOR SCHEDULED TRIBES FILE: NCST/SER-268/AP/7/2022-SSW

Minutes of the sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi, in the case of Shri Sugali Vinod Kumar Naik, Anantapuramu Distt (AP) regarding denial of offer of appointment to the post of Panchayat Secretary (Grade VI Digital).

Shri Sugali Vinod Kumar Naik, Anantapuramu Distt. (AP), vide representation dated 23.08.2021 has stated that he had applied for the post of Panchayat Secretary (Grade-VI) Digital Assistant under the PH (ST) reservation quota as per Notification No. 02/2020. Despite securing 19.75 marks and undergoing certificate verification, his candidature was disqualified because he did not possess a degree with computers as one of the subjects. He contends that his B.Com degree included relevant computer-related subjects, making him eligible as per the notification. Additionally, he highlights that a relaxation was granted for Data Entry Operators working in Gram Panchayats, allowing any degree holders with a computer application certificate to apply. He seeks intervention from the National Commission for STs to direct the concerned authorities to either issue his appointment order or grant similar relaxation on humanitarian grounds, considering his 100% disability and his belonging to a downtrodden ST community.

- NCST vide Notice dated 09.03.2022 has referred the matter to the Principal Secy, Panchayati Raj and Rural Development Department, Govt. of AP and the District Collector, Ananthapuramu for facts and comments.
- The DM and Collector, Ananthapuramu District, vide letter dated 29.03.2022, informed 3. that Shri Sugali Vinod Kumar Naik was not eligible for the post of Panchayat Secretary Gr-VI (Digital Assistant) under the Hearing Handicapped (HH) quota. The rejection was based on two grounds: (i) he did not possess the prescribed qualification as per Notification No. 02/2020, as his B.Com degree did not explicitly mention "Computers" as one of the subjects, and (ii) as per the medical examination conducted by the Superintendent, ENT Hospital, Visakhapatnam and verified by the Assistant Director, Welfare of Differently Abled, Transgender and Senior Citizens, Ananthapuramu, he did not meet the required percentage of hearing disability as per G.O.Ms. No. 31, dated 01.12.2009. Accordingly, he was issued a notice on 17.09.2021 declaring his ineligibility for the said post. This reply was also endorsed by Principal Secy, Panchayati Raj and Rural Development Department, Govt of AP vide letter dated 17.04.2022. This was forwarded to petitioner on 12.5.2022 for information.
- NCST has decided to discuss the issue with the concerned authority and petitioner on 5.3.2025. Accordingly, a sitting was issued on 21.2.2025 to all concerned.
- The Collector & District Magistrate, Anantapuramu vide letter dated 1.03.2025 has sought the exemption and deputed District Panchayat Officer (DPO), Anantapuramu to attend the sitting. In the sitting, the District Panchayat Officer, Anantapuramu and petitioner were present. The petitioner reiterated his earlier submission and requested for issuance of appointment letter to the post of Panchayat Secretary (Grade VI Digital). The DPO, Anantapuramu reiterated the facts submitted by District Collector, Anantapuramu vide letter dated 29.03.2022 and stated that the petitioner has not possessed the prescribed qualification for the said post.

- 6. After discussion with the DPO, Anantapuramu and petitioner, the following recommendations were made and action taken thereon may be submitted within 30 days from the receipt of the minutes.
- a. The District Collector may seek relaxation from PR&RD Department, Government of Andhra Pradesh so as to accomodate the petitioner on humanitarian grounds considering his disability as he belongs to a downtrodden ST community.
