

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri Karam Raj Soren, Village- Anlasul, PO-Khuntha, District – Mayurbhanj regarding non-implementation of High Court order.

Shri Karam Raj Soren, Village- Anlasul, PO-Khuntha, District-Mayurbhanj had submitted a representation dated 05.08.2021 regarding non-implementation of High Court Order dated 1.12.2020 by the Municipal Council, Baripada.

2. NCST decided to discuss the issue with the authority and the petitioner to resolve the grievance. A sitting notice was issued to District Magistrate, District – Mayurbhanj, Odisha on 04.02.2025 for attending the sitting on 12.02.2025. The petitioner was also informed to attend the sitting.

3. In the sitting, Addl. District Magistrate, Mayurbhanj was present on behalf of the District Magistrate, Mayurbhanj. The petitioner was absent. In the sitting the Addl. District Magistrate, Mayurbhanj has reiterated the facts submitted by the Collector & District Magistrate, District – Mayurbhanj vide their letter dated 5.2.2025. He has also provided a copy of letter no. 469 /Judl dated 09.2.2025 of Collector & District Magistrate, Mayurbhanj. In this letter, it has been informed that Shri Karam Raj Soren resides over plot no. 184 area Ac.1.00 dec, kisam Gharabari vide khata No. 65 of village Anlasul under Khuntha Tahsil, Dis- Mayurbhanj which is recorded in the name of Sri Iswar Chandra Soren (father of Sri Karam Raj Soren) and others. Further, the total land possessed by Sri Iswar Chandra Soren (father of Sri Karam Raj Soren) & his family members comes to measuring a total area Ac. 23.96 dec. So it is clear from the report of Tahasildar, Khuntha that, the petitioner is not homesteadless person who is liable for allotment of Govt. Land in his favour. Hence, the petition of Sri Karam Raj Soren who does not belong to Baripada Municipality area, for settlement of Govt. of land encroached by him in Municipality area of Baripada is not considerable under the provisions of existing rule of the land.


