## NATIONAL COMMISSION FOR SCHEDULED TRIBES (F.NO. NCST/DEV-2553/AP/43/2024-ESDW)

Minutes of the sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi, in the case of Shri Vanthala Nageshwer Rao, State Vice President, Adivasi Samkshema Parishath, Andhra Pradesh, Opp. Govt. Elementry School, Village-Kantabounsuguda, Post & Madal - Arakuvalley, District-Alluri Sitaramaraju, Andhra Pradesh regarding encroachment of land.

Shri Vanthala Nageshwer Rao, State Vice President, Adivasi Samkshema Parishath, Andhra Pradesh, vide his representation dated 20.12.2023, has stated that he is a resident of Pedalabudu Panchayat, Araku Valley Zone, Alluri Sitaramaraju District, belonging to the Scheduled Tribe (Valmiki), has been unlawfully dispossessed of his land by non-tribal individuals—Chukka Simhachalam Naidu and Ranga Venkata Ramanamurthy. The petitioner, who has been residing in the Scheduled Area and paying house taxes and electricity bills, alleges that the said non-tribals encroached upon his property, insults and threats to his life. Despite complaints to local authorities, including caste-based Mandal Tehsildar, Sub-Collector Paderu, ITDA Project Officer, and Visakhapatnam District Collector, no effective action has been taken. The petitioner invokes the protection of special laws governing Scheduled Areas, including the Andhra Pradesh Land Transfer Regulation 1 of 1970 and relevant seeks urgent intervention from the Hon'ble Member of the National Commission for Scheduled Tribes (NCST) to take suo moto cognizance of the matter, register a case against the encroachers, and ensure his safety and rights over his land.

- 2. NCST Notice dated 05.02.2024 to the Collector and District Magistrate, Alluri Sitaramaraju District, Govt of Andhra Pradesh for facts and comments within 15 days. The reply was not received, hence, the NCST has decided to discuss the issue with the authority and the petitioner on 18.2.2025. Accordingly, a Sitting Notice was sent on 7.2.2025. The sitting was postponed.
- 3. The Collector & District Magistrate, District Alluri Sitharama Raju vide letter no. 52/2025/E1 dated 11.2.2025 has furnished the facts and comments. In the letter it has been stated that the petitioner has no right/ title over the above land and his claim over the land is highly objectionable as subject land is purely vested to the Endowment Department since, 1964. In these circumstances, the request of the petitioner is not admissible. Hence, the NCST has decided to discuss the issue with the authority and the petitioner on 5.03.2025. Accordingly, a Sitting Notice was sent on 21.02.2025.
- 4. In the sitting, the Collector, District Alluri Sitharama Raju and petitioner were present. The petitioner has reiterated his earlier submission. During the sitting the petitioner has brought to the Notice to Commission that in the year 2023 Shri Varaha Lakshmi Narsimha Swami Devasthanam, Simhachalam, Visakhapatnam District has given Notice to him .The Collector ,District Alluri Sitharama Raju has reiterated their earlier submission and stated that as per report of sub collector, paderu the petitioner has no right/ title over the above land and his claim over the land.

- After discussion with both the parties, the following recommendations were made with a direction that action taken thereon may be submitted to NCST within 30 days from the receipt of
- a. The petitioner may be provided with the information of relevant documents relating to the ownership of the said land by Endowments Department which is already sought under RTI.

  b. As the petitioner is claiming a mere 3 cents of land for the livelihood, the same may be made available demarcating the boundary wall of the temple. c. The provisions of Land Transfer Regulations may be strictly complied by the Administration and it

may be ensured that no violations of LTR provisions are tolerated.
