Minutes of the sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi, in the case of N.G. Patel, General Secretary, AISCST Employees Welfare Association, ONGC, Agartala regarding irregularity by ONGC.

**Date of the sitting: 04.03.2025 at 2:30 PM**  
**Participants in the Sitting - As per Annexure**

Shri N.G. Patel, General Secretary, AISCST Employees Welfare Association, ONGC, Agartala vide his representation dated 27.9.2024 has alleged that ONGC is conducting CEC meeting on 1.10.2024 at Dehradun with illegally nominated office bearers of AISCST Employees Welfare Association inspite of Court order.

2. NCST vide notice dated 09.12.2024 has referred the matter to Chairman and CEO, ONGC, New Delhi for furnishing the facts and comments within 30 days from receipt of the Notice. The reply was not received. Meanwhile, Petitioner vide letter dated 1.02.2025 has again submitted a representation in which he has requested to put on hold the CEC meeting scheduled for 06.02.2025 at Dehradun. The representation was again referred to Chairman and CEO, ONGC, New Delhi for appropriate action vide NCST letter dated 04.02.2025. The reply was not received.

3. Hence, NCST has decided to discuss the issue with the concerned authority and petitioner on 04.03.2025. Accordingly, a Sitting Notice was sent on 24.2.2025 to all concerned.

4. The Chairman & CEO, ONGC vide letter no. CH/03 dated 3.3.2025 has sought exemption and deputed Executive Director (Chief – Employee Relations) alongwith other Sr. officers to attend the sitting. In the sitting, the ED alongwith other Sr. officer of ONGC was present but the petitioner was not present.

5. The ED, ONGC informed that the management is holding the CEC meeting with the AISCST Employees Welfare Association. It was also informed that the Regional offices of ONGC has also Regional SC/ST Employees Welfare Association. The allegations leveled by petitioner are baseless. Hence, the case may be closed.

6. After discussion with the ED, CLO and with other officers of ONGC, it was decided that there is no role of NCST. Hence, the case may be closed. However it is recommended that The SC and ST Associations in ONGC may be separated and recognised.
