Minutes of the sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi, in the case of Shri Asha Ram Meena, Sr. Administrative Officer, Rural Health Training Centre, Najafgarh, New Delhi regarding harassment of ST Officer by the Ministry of Family and Health Welfare.

**Date of the sitting: 04.03.2025 at 2:30 PM**  
**Participants in the Sitting - As per Annexure**

Shri Asha Ram Meena, Sr. Administrative Officer, Rural Health & Training Centre, Najafgarh, New Delhi vide his representation dated 16.12.2024 has stated that he is presently working as Sr. Administrative Officer (after Promotion vide MoFHW order dated 20.07.2023 and 24.07.2023) previously working in Safdarjung Hospital, New Delhi. He states that there was no proper sitting arrangement and officials meetings attended by Head Clerk of the Office. Moreover, he states that he is at the verge of retirement and his health condition does not allow him to travel from East Kidwai Nagar to Najafgarh i.e. two hours single side. Hence, do the justice.

2. NCST vide notice dated 27.12.2024 has referred the matter to Secretary, Ministry of Health and Family Welfare, New Delhi for furnishing the facts and comments within 30 days from receipt of the Notice. The reply was not received. Hence, NCST has decided to discuss the issue with the concerned authority and petitioner on 04.03.2025. Accordingly, a Sitting Notice was sent on 24.2.2025 to all concerned.

3. The Secretary, Department of Health and Family Welfare, New Delhi vide DO No. V-28020/02/2025-H-II dated 27.2.2025 has sought exemption and deputed officers of the concerned department to attend the sitting. In the letter it was also informed that a reply on the issue raised by the applicant in his representation is being sent separately. The Department of Health & Family Welfare letter no. V-28020/02/2025-H-II- Part (1) dated 4.3.2025 has furnished the facts and comments along with reply of the RHTC.

4. In the sitting, the officers from Department of Health and Family Welfare, Director General of Health Services (DGHS), Safdarjung Hospital, RHTC and petitioner were present. The petitioner reiterated his earlier submission and alleged that the D/o Health and Family Welfare posted him at RHTC as there is no post of Sr. Administrative Officer and there were no proper seating arrangements and space in the office. Already he has undergone 2 years of punishment and at the verge of retirement. The officer of D/o Health & Family Welfare has reiterated the comments submitted by their department to NCST vide letter dated 4.3.2025. The authority has informed that action is taken by the ministry and not the safdarjung hospital and as per CVC guidelines as during the enquiry process as the employee is not supposed to be in his place he is made to work in RHTC. The enquiry report is already submitted to Ministry.

5. After discussion with Department of Health and Family Welfare, Director General of Health Services (DGHS), Safdarjung Hospital, RHTC and petitioner were present, it was recommended that the petitioner may be transferred from RHTC to Safdarjung Hospital, as there is no post of Sr. Administrative Officer at RHTC and as there is no evidence obtained against him in the enquiry process. The action taken thereon may be submitted to NCST within 15 days from receipt of the minutes.
