## NATIONAL COMMISSION FOR SCHEDULED TRIBES NCST/SER-1867/TS/194/2025-RO-BHUV/RU-III

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Shri R. Bhona, Superintendent, Telangana Housing Board, Warangal Division regarding delay in rightful promotion.

Date of the Sitting: 26/03/2025, 04:10PM Participants in the Sitting: As per Annexure

Shri R. Bhona, Superintendent, Telangana Housing Board, Warangal Division, vide his petition dated 13.12.2024 has stated that he has been denied promotion to the post of Assistant Estate Officer despite being ranked first in the seniority list issued on 16.01.2023. He alleges that his promotion has been withheld solely due to a pending charge memo dated 26.11.2019 and CC No.8016/2020, despite an abnormal delay in the disciplinary proceedings. Aggrieved by this he filed WP No.33969/2024 before the Hon'ble High Court which through an interim order dated 03.12.2024 directed the authorities to consider his promotion without reference to the charge memo and CC in accordance with G.O.Ms.No.257 dated 10.06.1999. He further states that he is nearing superannuation on 30.03.2025 and requests the Commission to forward his appeal to the Vice Chairman and Housing Commissioner, Telangana Housing Board for immediate implementation of the High Court's order.

- 2. NCST vide notice dated 01.01.2025 has referred the matter to Vice Chairman and Housing Commissioner, Telangana for facts and comments. The Vice Chairman & Housing Commissioner, Telangana Housing Board, by his letter dated 13.02.2025, has informed the Commission that the case of Shri R. Bhona, Superintendent, regarding his promotion to the post of Assistant Estate Officer without reference to the Charge Memo dated 26.11.2019 and Criminal Case No.8016/2020, has been examined in pursuance of the interim order of the Hon'ble High Court dated 03.12.2024 in W.P.No. 33969/2024. It has been decided to place his case before the Departmental Promotion Committee/Screening Committee by convening a meeting as per the prescribed procedure. However, due to the enforcement of the Model Code of Conduct following the announcement of the schedule for the Biennial Elections for three MLC constituencies, the Screening Committee meeting will be scheduled appropriately, and proceedings will be issued accordingly. This was sent to the petitioner for information vide NCST letter dated 20.02.2025.
- 3. NCST decided to discuss the issue with the authority and the petitioner on 26.03.2025. Accordingly, a Sitting Notice was sent on 12.03.2025.
- 4. In the sitting, Secretary and PRO, Telangana Housing Board and petitioner were present. The petitioner reiterated his earlier submission and requested to promote to the next post as he will be superannuated on 31.3.2025. The officers of Telangana Housing Board assured that a meeting of DPC is fixed for 28.3.2025 to consider his case.
- 5. After discussion with the officers of Telangana Housing Board and petitioner, it was observed that there has been an inordinate delay in conclusion of disciplinary proceedings and non-compliance of the interim orders of Hon'ble High Court.
- 6. It is recommended that the DPC for promotion to the petitioner may be immediately convened on or before 28.3.2025, as assured by the officers of Telangana Housing Board in the sitting to consider the promotion of the petitioner as per his seniority and eligibility without any further delay as he is being superannuated on 31.3.25. The Travel Allowance and Special leave may be reimbursed / granted in favour of petitioner by the Telangana Housing Board as per entitlement of the petitioner. The action taken in the matter may be communicated to NCST within 15 days from the receipt of the minutes.
