## NATIONAL COMMISSION FOR SCHEDULED TRIBES NCST/ATY-2061/TS/173/2024-RO-BHUV/RU-III

Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi in the case of Smt Sapavath Sakkubai, 15-192 EP, Road No. 9, Thirumala Nagar, Almasguda, BN Reddy Nagar regarding posting of Smt Ch Sujatha, MPPS, Sivannaguda, Marriguda Mandal.

Smt Sapavath Sakkubai, 15-192 EP, Road No. 9, Thirumala Nagar, Almasguda, BN Reddy Nagar, District Ranga Reddy vide petition dated 18.12.2024 has represented that there are irregularities in the transfer of teachers, particularly concerning the posting of Smt Ch Sujatha (SGT), MPPS, Sivannaguda, Marriguda Mandal, as per GO 317. She has therefore requested necessary action in this regard.

- 2. NCST vide notice dated 1.1.2025 has referred the matter to Director of School Education, Hyderabad for facts and comments within 30 days from receipt of the Notice. The Director of School Education, Telangana, vide letter no 7/SER/RC-1/2025 dated 25.02.2025, has submitted a report in response to the complaint by Smt. Sapavath Sakkubai, SGT, regarding the transfer of Smt. Ch. Sujatha, SGT, MPPS, Shivannaguda under G.O.Ms.No.317. The report states that Smt. Ch. Sujatha and her husband had applied for a transfer on spouse grounds, but only she was allotted to Yadadri Bhuvanagiri District, where she did not report. Later, based on humanitarian grounds, she was reallocated to Nalgonda District. Regarding the allegation of caste discrimination, the inquiry found no evidence to support the claim, with statements from school staff and officials confirming that the dispute primarily involved seniority issues. The report concludes that the transfer of Smt. Ch. Sujatha was done as per the applicable rules, and no caste-based discrimination was found. This was forwarded to petitioner 3.3.2025 for information.
- 3. The Commission decided to discuss the issue with the authority and the petitioner on 27.03.2025. Accordingly, a Sitting Notice was sent on 17.03.2025. The Director, School Education, Govt. of Telangana, Hyderabad vide letter dated 24.3.2025 has sought exemption alongwith detail report in the matter and deputed District Education Officer, Nalgonda to attend the sitting.
- 4. In the sitting, District Education Officer, Nalgonda and petitioner were present. The petitioner reiterated her earlier submission that she is being harassed by Smt Ch. Sujatha who has been backbiting her and humilating her by speaking adversely against the petitioner and requested for justice. Further certain photocopy of the attendance register is submitted where in some manipulation appeared to be evident. District Education Officer, Nalgonda has also reiterated the facts submitted by the Director of School Officer, Telangana in its letter dated 25.2.2025 and also the facts submitted by the Director of School Education, Govt. of Telangana vide letter dated 24.3.2025.
- 5. After discussion with the District Education Officer, Nalgonda and petitioner, the following recommendations were made and action taken thereon may be submitted to NCST within 30 days from receipt of the minutes.
- Detailed enquiry may be made regarding the manipulation in the attendance register and if proved disciplinary action may be taken.
- It may be examined to transfer the the person who is harassing the ST teacher in an obsure way.
- The awareness sessions may be conducted to the teachers about their duties and a sense of fraternity among teachers may be fostered as they are involved in upbringing of children who are the future of the nation.
- The Travel Allowance and Special Leave may be reimbursed/granted in favour of the petitioner, as per their entitlement by District Education Officer, Nalgonda
